XII. Comments from Council

Councilperson Stone spoke about the proposed properties for the Oklahoma County jail relocation. He requested metrics for each of the properties that The City of Oklahoma City has proposed to the county in terms of its proximity to downtown, schools, parks, residential areas, and the availability of transportation, because he keeps hearing that each of these proposed locations would not work because of the closeness of schools and residences and there is a lot of political influence going on. This should not be a political issue, but more of what would work best for the county and our residents.

Mr. Freeman responded that he would work with the county on getting specific numbers. He noted when they were researching properties, the general parameters that the county gave them were between 30 and 70 acres; however, they preferred a little more to allow for expansion. Their zoning preference was light industrial, but it is not a requirement. He said any site that is selected within the city boundaries will require a special permit and must have direct access to utilities, be 10 to 15 minutes from downtown, be near a highway or major infrastructure like an arterial street for easier access and consider the buffer between residential areas and schools.

Councilperson Peck requested the same metrics for the existing Oklahoma County jail.

Councilperson Cooper discussed concerns about expanding or building a county jail with a capacity of over 2,000 after voters approved a diversion hub in MAPS 4, and leaders have done advocacy work for well over a decade towards criminal justice reform, addressing mental health, and the reduction of incarcerated people. He said the idea that we are talking about expanding anything related to jail rather than reducing our adverse childhood experience scores in the adults who have them is baffling, and it flies in the face of all the data-driven research the City and Vera Institute have done; it undercuts the work of the diversion hub and the important work that this City Council, the business community, and civic leaders have done. Councilperson Cooper shared a story about an inmate that was on death row, exonerated, released, and found to have cancer but had no access to any type of stabilization services. He thanked Councilmembers Stone and Peck for their comments, and he requested staff to provide a clear understanding about the jail expansion, and metrics specifically about access to homelessness services, the diversion hub, food, and stabilization of those previously incarcerated whether it was for a day, a week, or a year.

Councilperson Nice stated that the county jail issue has been a tiring process for all those who have had locations proposed within the areas they are a part of. She noted all the sites are political; it is just a matter of where you are going to put it. Her grave concern is that we are not having full conversations with those that are within the communities until we have determined the sites, and even afterwards, most times, we do not afford them the needed conversations to ask why; it is just how we say what is important to and what communities are important for our city. She mentioned that there were discussions at meetings she sat in about people arriving at their district court appointments late from the current jail location, which, in her opinion, is an internal issue that needs to be filtered as we work through keeping it at its existing location.

Councilperson Nice announced a Ward 7 Town Hall on January 23, 2024, at the Greater Mount Olive Baptist Church Family Life Center, located off NE 42nd Street and North Kelley Avenue, at 6:00 p.m. She expressed she is very grateful to the pastor and congregation for allowing us the opportunity to have this conversation at this location in our community.

Councilperson Nice stated it was unusual to not be downtown celebrating and honoring the legacy and 95th birthday of Dr. King. She announced the parade and breakfast will be on January 27th, and the cross-cultural dinner at Temple B'nai Israel will be on February 25th. She encouraged those who have not taken part in a program as such to please make time to do so. It is an important day to commemorate our differences and familiarities in Dr. King's struggle for equality that we are still fighting for in this present time, 50 years later. She mentioned the job fair will still happen, and you can visit okcmlkalliance.org for more information.

Councilperson Stonecipher also mentioned that this year is the 50th anniversary of OKC Friday. He congratulated and thanked Vicki, Rose, and the staff, and he remembered Leland Gourley, who was a great editorial writer. He said this newspaper has been timely, relevant, and had a big impact on the things that have happened in Oklahoma City. He noted Gordon Walker, a former employee, wrote: "One thing that Friday has always done well is to celebrate achievement, education, business, and civic participation; and on the fields and courts of athletics, Friday editorials always encourage city leaders, civic giants, and decision makers to dream big while employing readers to follow and support."
