**I. SCOPE**

Change Order No. 1 adds a new pay item and revises the contract start and completion dates.

**II. JUSTIFICATION**

Change Order No. 1 adds pay items for Aggregate Base (Type A) and revises the contract start and completion dates. The aggregate base is required to strengthen the base before placing concrete panels. The contract has the provision for a 90 days Flex Start, moving the completion date by to November 7, 2022. No additional days were added.

Change Order No. 1 is an increase of \$50,000.00 or 1.72 percent above the original contract amount. The revised contract amount is \$2,949,438.80.

**V. CONTRACT TIME**

The original contract called for 245 calendar days. The contract has the provision for a 90 days Flex Start, Instructions to Bidders 19.9. This moved the start and completion date by 90 days. The revised start date is March 7, 2022, and the completion date is November 7, 2022. No additional days were added. The total contract duration is 245 calendar days.


