**SUBJECT:** Memorandum of Agreement Appointing OCWUT as a Government Authorized User on a Temporary Right of Entry License USAF-AFMC-WWYK-23-1-014.

1. This memorandum of agreement serves as notice that the Government recognizes the OKLAHOMA CITY WATER UTILITIES TRUST (OCWUT); a public trust, located at 420 W Main Street, Oklahoma City, OK 73102 as the sole Government Authorized User on a temporary right of entry real estate license USAF-AFMC-WWYK-23-1-014 issued under the authority contained in 10 U.S.C. § 9013. A copy of this memorandum of agreement will be furnished to the Licensor prior to the Term Beginning Date of 22 January 2024 in accordance with clause 13 Assignments of the temporary license.

2. As the sole Government Authorized User, OCWUT will comply with all terms identified in the real estate license USAF-AFMC-WWYK-23-1-014. This License will be executed at no cost to the Government. All costs associated with the terms of the license are OCWUT's sole responsibility.

3. It is expressly agreed that License USAF-AFMC-WWYK-23-1-014 embodies the entire agreement between the Parties regarding the use of the Licensed Premises by the Government and its Authorized User, OCWUT. There are no understandings or agreements, verbal or otherwise, between the Parties except as expressly set forth in the License and acknowledged in this memorandum of agreement.

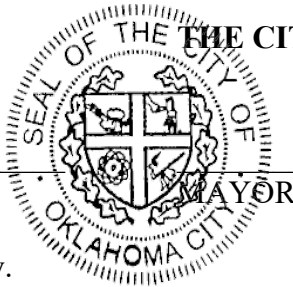
