**AN ORDINANCE RELATING TO GENERAL SCHEDULE OF FEES FOR BUILDING, ELECTRICAL, PLUMBING, AND MECHANICAL BOARD OF APPEALS; AMENDING CHAPTER 60 OF THE OKLAHOMA CITY MUNICIPAL CODE, 2020, BY REPEALING TITLE 12, ARTICLE II, SECTIONS 60-12-14 THROUGH 60-12-18, TITLE 18, ARTICLE I, SECTIONS 60-18-1 THROUGH 60-18-5, TITLE 29, ARTICLES II AND III, SECTIONS 60-29-6 THROUGH 60-29-15, AND TITLE 42, ARTICLE II, SECTIONS 60-42-12 THROUGH 60-42-15 IN ITS ENTIRETY; ENACTING A NEW TITLE 12, ARTICLE II, SECTION 60-12-14 THROUGH 60-12-18, TITLE 18, ARTICLE I, SECTIONS 60-18-1 THROUGH 60-18-5, TITLE 29, ARTICLES II AND III, SECTIONS 60-29-6 THROUGH 60-29-15, AND TITLE 42, ARTICLE II, SECTIONS 60-42-12 THROUGH 60-42-15 OF CHAPTER 60 OF THE OKLAHOMA CITY MUNICIPAL CODE, 2020; AND PROVIDING FOR AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.**

**EMERGENCY ORDINANCE**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:**

**SECTION 1.** That Chapter 60, Title 12, Article II, Sections 60-12-14 through 60-12-18, Title 18, Article II, Sections 60-18-1 through 60-18-5, Title 29, Articles II and III, Sections 60-29-6 through 60-29-15, and Title 42, Article II, Sections 60-42-12 through 60-42-15 of Chapter 60 of the Oklahoma City Municipal Code, 2020, are hereby repealed in their entirety.

**SECTION 2.** That Chapter 60 of the Oklahoma City Municipal Code 2020, is hereby amended by enacting a new Title 12, Article II, Sections 60-12-14 through 60-12-18, Title 18, Article II, Sections 60-18-1 through 60-18-5, Title 29, Articles II and III, Sections 60-29-6 through 60-29-15, and Title 42, Article II, Sections 60-42-12 through 60-42-15 of Chapter 60 of the Oklahoma City Municipal Code, 2020, to read as follows:
