Concurrence with the Oklahoma City Water Utilities Trust in approving Amendment No. 1 and Change Order No. 1 with Southwest Water Works, LLC, Project WC-0975, Airport Fire Suppression Extension, Air Cargo Road, increase of \$23,910.20; accepting the project and placing the maintenance bond into effect. Ward 3.

Location:

Air Cargo Road

Purpose:

To adjust the pay quantities to close out the project.

Justification:

It is necessary to adjust the plan quantities to match the actual quantities for completion of the project.

Background:

This project installed a dedicated fire suppression line that loops the system that serves the Will Rogers World Airport to provide service redundancy and improve reliability. The Oklahoma City Airport Trust (OCAT) and the Oklahoma City Water Utilities Trust (OCWUT) agreed to contract the improvements for the project. Construction costs and expenses were reimbursed to OCWUT by OCAT.

Fidelity and Deposit Company of Maryland is the surety company for the two-year maintenance bond. Bond No. 9414238 will remain in effect until the contractor and surety have fulfilled all responsibilities under the maintenance bond.
