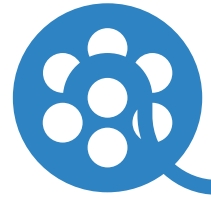

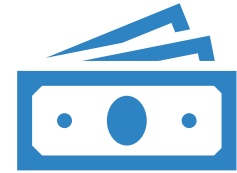
## PROJECT DESCRIPTION

- ▶ Small budget, independent film
- ▶ Crime drama set in a small town
- ▶ Filming days are May 21 - June 23, 2024



## PRODUCTION TEAM

- ▶ Oklahoma-based Producer/Director, Kyle Kauwika Harris and Producer, Jacob Snovel
- ▶ The production team behind the Oklahoma made films “Out of Exile,” “Country Gold,” and “What Rhymes With Reason”
- ▶ Production utilizing OKC facilities, Filmmakers Ranch, and Boiling Point Media



## OKC IMPACT

- ▶ 94% OKC-based crew
- ▶ Anticipated OKC expenditures totaling \$1,551,405 (87%)

## PROJECT QUALIFICATIONS

### **Feature Film with total Qualified Expenditures of at least \$500,000**

- Project Mystery is anticipated to have local qualified expenditures of \$1,551,405

### **Pre-Qualifications for Incentive Award**

- Expenditures of at least \$500,000 on a feature film
- 50% of filming days in OKC
- Main production office located within city limits of OKC (Filmmakers Ranch)
- Post-production taking place at Filmmakers Ranch and Boiling Point Media
- Pre-qualified for the State of Oklahoma's film incentive

### **Eligible to receive up to 5% rebate of eligible expenditures**

- Recommended Rebate Allocation for Project Silence: \$64,813

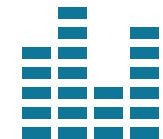

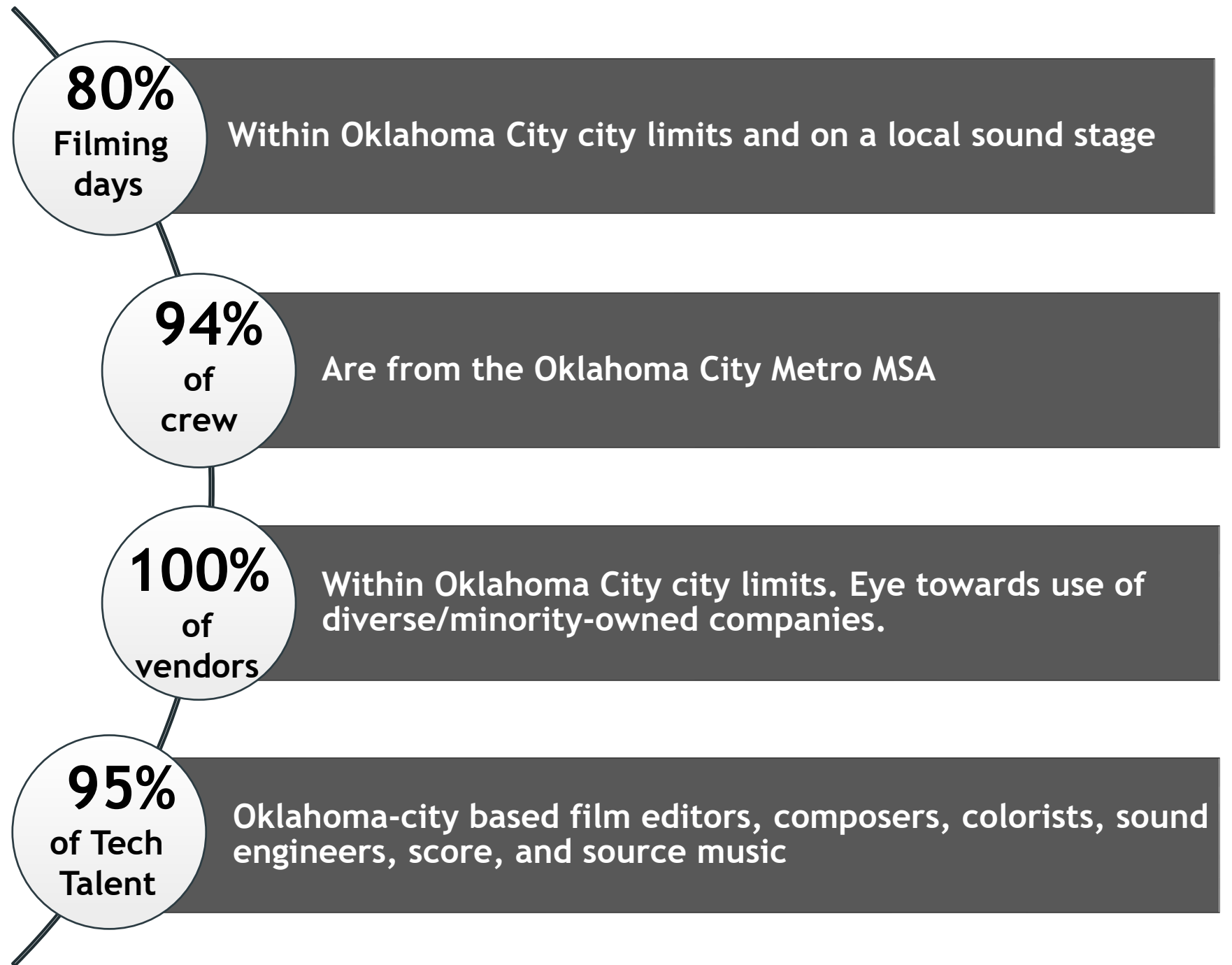
