**XII.**        **Comments from Council**

Councilmember Carter wished everyone a Merry Christmas. He said it was an honor to be here; he enjoys it and looks forward to the next few years.

Councilmember Cooper spoke about accessory dwelling units in historic preservation neighborhoods within Ward 2. He stated that conversations need to be had with the historic neighborhood associations, and we need to reach out to the residents that normally do not attend their association meetings for their input. He suggested bringing Advisory representative Lindsey Pever and the current president of the Edgemere Park Neighborhood Association to the table for those conversations. He said he shares the concerns of his neighbors that people outside of the state and city will come in and purchase their homes, four-plexes, and duplexes, then tear them down and build something much bigger, unaffordable, and characterless, not in harmony with historic neighborhoods such as Putnam Heights, Edgemere Heights, and Heritage Hills. He asked the Council to be mindful of the protections these neighborhoods would want and to have pre-approved plans with an inventory of architecturally harmonious buildings that fit the designs of both the historic and non-historic neighborhoods. He also encouraged the City Council to bring their concerns to the table and educate people on the overall housing crisis and our bigger plan in Chapters 6 and 7 of the Affordable Housing Study, which lays out affordable housing recommendations for the General Obligation Bond.

Councilmember Cooper thanked City Manager Craig Freeman, Councilmember Carter, Laura McDevitt, and John Stringer for attending the Full Circle book reading; it was standing room only. He said he appreciated their support and thanked them for listening to him speak about housing and education, which are near and dear to his heart.

Councilmember Cooper wished everyone Happy Holidays.

Councilmember Peck reminded Councilmember Cooper to sign her book before leaving today. She said it was very hard to come by and popular.

Councilmember Peck expressed her gratitude to newly elected House Representative Emily Gise and Councilmember Matt Hinkle for including her in the Oklahoma Department of Transportation conversation with Tim Gatz, Monty, and a slew of engineers regarding the bridgework on SW 119th Street and SW 134th Street at I-44. She said the plan has now been revised, so we will not shut down two bridges at one time. She noted that the Oklahoma Department of Transportation will provide more information about it, and she will share it with the residents in the area.

Councilmember Hinkle congratulated Councilmember Stone on receiving the Humanitarian Award from the Oklahoma City Metropolitan Association of Realtors last week; it was well deserved.

Councilmember Hinkle said, Happy Holidays, Merry Christmas, and Thunder Up!

Councilmember Cooper, Jr. congratulated Councilmember Carter on his appointment. He said it is good to finally meet him, and he is excited.

Councilmember Cooper, Jr. thanked the City Council for their help with PUD-2016, which was a difficult assignment. He requested the Council take under consideration everything that has been said today when they go visit the property. He also mentioned that one of the neighbors that presented today was threatened to have the police come and escort them out of the Planning Commission meeting, and they were offended by that because they were trying to get their point across. He said when you see people at City Council who do not have the words or know the lingo but try to communicate specific messages of their concerns, make sure to always treat them with compassion and care; it is crucially important.

Councilmember Cooper, Jr. thanked the council members for all the gifts. He said he did not know they were bearing gifts today or what he needed to do to make it up.


