RESOLUTION APPROVING THE AMENDMENT TO THE 2020 YOUTH HOMELESS DEMONSTRATION PROGRAM GRANT AGREEMENT WITH THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND FIRST AMENDMENT TO THE OPERATING AGREEMENT WITH THE HOMELESS ALLIANCE, INC. FOR PROJECT NO. OK0185Y6I021900, INCREASING THE OVERALL SUPPORTIVE SERVICES BUDGET BY \$6,016; TRANSFERRING \$34,000 FROM THE SUPPORTIVE SERVICES COMPONENT TO THE LEASING COMPONENT AND \$16,000 FROM THE OPERATIONS COMPONENT TO THE LEASING COMPONENT; AND EXTENDING THE TERM THROUGH DECEMBER 31, 2024.

WHEREAS, on September 15, 2021, the United States Department of Housing and Urban Development (HUD) selected Oklahoma City to receive Youth Homelessness Demonstration Program (YHDP) Federal grant funding; and

WHEREAS, the initial two-year \$3,028,026.33 (three million, twenty-eight thousand, twenty-six dollars and thirty-three cents) grant was awarded to the City of Oklahoma City as the YHDP's lead organization; and

WHEREAS, on August 2, 2022, the City Council approved submittal of the application to HUD to fund the five (5) new projects and for Planning Project Grant funds under the award (Item No. IX. AQ); and

WHEREAS, agreements for all projects, including the Homeless Alliance Operating Agreement, were approved by the City Council on December 6, 2022 (Item No. IX. W); and

WHEREAS, due to difficulties in locating suitable properties to lease for this Project, Homeless Alliance has requested an amendment to include a time extension and budget revisions; and

WHEREAS, HUD approval of this Amendment is required and is attached for signature; and

WHEREAS, this item will also amend the Agreement for Project OK0185Y6I021900 with the Homeless Alliance, Inc., to extend the term from December 1, 2022 through November 30, 2024, to December 1, 2022 through December 31, 2024, and will transfer \$34,000 from the Supportive Services component to the Leasing component as well as \$16,000 from the Operations component to the Leasing component; and

WHEREAS, additionally, the Amendment will add \$6,016 to the overall Supportive Services budget; and

WHEREAS, when the original operating agreement was approved in December of 2022, the Services budget was incorrectly listed as \$273,000 rather than \$279,016; and

WHEREAS, the addition of these funds will correct the budget allocated to the Supportive Services component; and

WHEREAS, this Amendment will allow the program funds to continue to be used for a greater period of time, and for services of the highest need.



NOW, THEREFORE, BE IT RESOLVED, by the Mayor and the City Council of the City of Oklahoma City that:

- 1) The amendment to project OK0185Y6I021900 with Homeless Alliance, Inc. extending the term from December 1, 2022 through November 30, 2024 to December 1, 2022 through December 31, 2024; increasing the overall Supportive Services budget by \$6,016; transferring \$34,000 from the Supportive Services component to the Leasing component and \$16,000 from the Operations component to the Leasing component, is approved; and
- 2) The amendment to project OK0185Y6I021900 with the United States Department of Housing and Urban Development is approved.
