

RESOLUTION

A RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY ESTABLISHING A DATE FOR THE PROPOSED ENACTMENT OF AN ORDINANCE CLOSING A PUBLIC WAY OR EASEMENT, DETERMINING THOSE ENTITLED TO NOTICE OF SAME, AND DIRECTING THAT SAID NOTICE BE ISSUED.

WHEREAS, an application to close the following described public way or easement has been considered by the Planning Commission of The City of Oklahoma City as part of a Master Plan or amendment of same, to-wit:

All of the North/South Alleyway lying in Block Twenty (20), COMMERCIAL VIEW ADDITION, recorded in Book 16 of Plats, Page 96, Oklahoma County Clerk's Office, City of Oklahoma City, Oklahoma, being more particularly described as follows: BEGINNING at the Northwest corner of Lot 1, Block 20 of said COMMERCIAL VIEW ADDITION; THENCE South 00°21'19" West, along the west line of Lots 1 through 11 of said Block 20, a distance of 275.09 feet, to a point on the south line of said COMMERCIAL VIEW ADDITION; THENCE South 89°57'55" West, along said south line, a distance of 15.00 feet, to the southeast corner of Lot 47; THENCE North 00°21'19" East, along the east lines of Lot 47 and Lot 12, a distance of 275.09 feet, to the north line of said COMMERCIAL VIEW ADDITION; THENCE North 89°57'21" East, along said north line, a distance of 15.00 feet to the POINT OF BEGINNING.

WHEREAS, an ordinance closing the same is proposed to be considered by the City Council on the 20TH day of MAY, 2025; and

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that the City Clerk be and is hereby directed to give notice to the public by one publication in a newspaper of general circulation within the City and further to mail 30 days written notice to the following:

- C. All property owners within 300 feet of the public way or easement to be closed whose names appear on the ownership list required to be submitted as a part of this application.

Such notice shall state that an ordinance to close the aforesaid public way or easement has been proposed for enactment on the 20TH day of MAY, 2025. A copy of the resolution shall be included with said written notice.
