Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2023-0012550 styled: *Charles Dyer, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Charles Dyer is 51 years old and an 8-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Development Services Department as a Code Inspector I and continues to be employed by the City.

The Claimant sustained an undisputed accidental injury on April 17, 2023 to his left shoulder. The Claimant required surgery to his left shoulder on June 20, 2023 and February 27, 2024.

The Claimant was evaluated by Dr. Mark Shreve, on behalf of the City and found to have the following permanent partial impairment: left shoulder 3%. The negotiated Joint Petition Settlement calls for a PPD award of \$15,552 for the following permanent partial disability: left shoulder 12%.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$466.56 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award \$15,085.44. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$116.64 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$311.04.
