Notification from Water Taxi, LLC, of changes to excursion boat fare prices, Bricktown Canal, effective March 1, 2025. Ward 7.

Location:
Bricktown Canal

Background:
The Canal Boat Agreement ("Agreement") among the Oklahoma City Public Property Authority ("OCPPA"), The City of Oklahoma City, and Water Taxi, LLC ("Water Taxi"), dated April 13, 1999, as amended, states that Water Taxi is the exclusive provider of excursion boat and water transportation services at the Bricktown Canal.

The Agreement provides that Water Taxi may, upon notice to OCPPA and approval by the General Manager, adjust its fares. After careful consideration, Water Taxi is making certain changes to its fares for services at the Bricktown Canal. This item provides notification of that action.

The Standard/Peak Demand prices listed below, which include tax, are effective March 1, 2025:

Charter Fares will be updated as follows:

Effective March 1, 2025: \$350, plus tax.
Effective January 1, 2026: \$450, plus tax.
