

RESOLUTION

A RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY ESTABLISHING A DATE FOR THE PROPOSED ENACTMENT OF AN ORDINANCE CLOSING A PUBLIC WAY OR EASEMENT, DETERMINING THOSE ENTITLED TO NOTICE OF SAME, AND DIRECTING THAT SAID NOTICE BE ISSUED.

WHEREAS, an application to close the following described public way or easement has been considered by the Planning Commission of The City of Oklahoma City as part of a Master Plan or amendment of same, to-wit:

A tract of land situate within Lot 6 Block Six (6), Whistle Creek Phase II, a subdivision of the City of Oklahoma City, Oklahoma County, Oklahoma, recorded in Book 81, Page 3 and being more particularly described by metes and bounds as follows: COMMENCING at the Northeast corner of Lot 6 Block 6 of Whistle Creek Phase II; Thence N89°43'54"W along the north line of said Lot 6 a distance of 30.78 feet; Thence S00°16'06"W parallel with the East line of said Lot 6 a distance of 42.51 feet to the POINT OF BEGINNING; Thence S02°18'23"W a distance of 2.69 feet; Thence N89°17'58" W a distance of 1.03 feet to a point on a curve to the right; Thence 2.91 feet along the arc of said curve having a radius of 72.00 feet, subtended by a chord of 2.91 feet which bears N23°04'35"E to the POINT OF BEGINNING. **AND** A tract of land situate within Lot 7 Block Six (6), Whistle Creek Phase II, a subdivision of the City of Oklahoma City, Oklahoma County, Oklahoma, recorded in Book 81, Page 3 and being more particularly described by metes and bounds as follows: COMMENCING at the Northeast corner of Lot 7 Block 6 of Whistle Creek Phase II; Thence N89°43'54"W along the north line of said Lot 7 a distance of 23.01 feet; Thence S00°16'06"W a distance of 5.94 feet to the POINT OF BEGINNING; Thence S00°22'15"E a distance of 21.29 feet; Thence S85°47'58"W a distance of 1.78 feet to a point on a curve to the right; Thence 21.56 feet along the arc of said curve having a radius of 72.00 feet, subtended by a chord of 21.48 feet which bears N04°22'43"E, to the POINT OF BEGINNING.

WHEREAS, an ordinance closing the same is proposed to be considered by the City Council on the 31ST day of DECEMBER, 2024; and


NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that the City Clerk be and is hereby directed to give notice to the public by one publication in a newspaper of general circulation within the City and further to mail 30 days written notice to the following:

- A. All above listed franchise holders.
- B. All those having a special right or privilege as listed above.
- C. All property owners within 300 feet of the public way or easement to be closed whose names appear on the ownership list required to be submitted as a part of this application.

Such notice shall state that an ordinance to close the aforesaid public way or easement has been proposed for enactment on the 31ST day of DECEMBER, 2024. A copy of the resolution shall be included with said written notice.
