

**RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST RATIFYING THE ACTIONS OF THE GENERAL MANAGER IN DECLARING AN EMERGENCY; APPROVING THE BIDDING DOCUMENTS, APPROVING ADDENDUM NO. 1, AND AWARDING A CONTRACT TO URBAN CONTRACTORS, LLC, PROJECT SE-0059, EMERGENCY SANITARY SEWER AERIAL CREEK CROSSING REPLACEMENT, WINDOVER DRIVE AND COACHLIGHT DRIVE (EDMOND), \$208,040; RATIFYING ISSUANCE OF AN EMERGENCY WORK ORDER; AND APPROVING THE CONTRACT AND BONDS.**

**WHEREAS**, The City of Oklahoma City (Oklahoma City) owns and operates and the Oklahoma City Water Utilities Trust (OCWUT) leases and finances the Oklahoma City water system; and

**WHEREAS**, OCWUT purchases equipment and materials necessary for the continuous and efficient operation of the Oklahoma City water system; and

**WHEREAS**, this emergency project is required to replace a collapsing 8-inch sanitary sewer pipe; and

**WHEREAS**, the necessary repairs include the installation of a new sewer main, casing pipe, and two concrete piers; and

**WHEREAS**, the repairs were beyond the ability of the Utilities Department; and

**WHEREAS**, it is in the best interest of the public health, safety, and welfare that repairs be completed timely to restore the operational capacity in the area; and

**WHEREAS**, the General Manager declared an emergency to exist; and

**WHEREAS**, the emergency contract for Project SE-0059 in the amount of \$208,040 was awarded by the General Manager to Urban Contractors, LLC; and

**WHEREAS**, Urban Contractors, LLC has signed the contract and bonds for Project SE-0059 for the bid amount of \$208,040; and

**WHEREAS**, the City Engineer issued an emergency work order.

**NOW, THEREFORE, BE IT RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify the actions of the General Manager in declaring an emergency; approving the bidding documents, approving Addendum No. 1, and awarding a

contract to Urban Contractors, LLC, Project SE-0059, Emergency Sanitary Sewer Aerial Creek Crossing Replacement, Windover Drive and Coachlight Drive (Edmond), \$208,040; and

**BE IT FURTHER RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify issuance of an emergency work order; and

**BE IT FURTHER RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby approve the contract and bonds.
