ORDINANCE NO. 27,606

AN ORDINANCE RELATING TO THE GENERAL SCHEDULE OF FEES, AMENDING CHAPTER 60 OF THE OKLAHOMA CITY MUNICIPAL CODE, 2020, AMENDING TITLE – 33 – MUNICIPAL COURT, ARTICLE III – COURT PROCEDURE, BY AMENDING SECTION 60-33-11 - COURT COSTS; AMENDING ARTICLE IV – COURT OPERATIONS DIVISION, BY ENACTING SECTION 60-33-16 - FEES FOR OKLAHOMA CITY MUNICIPAL COURTHOUSE ATTORNEY PROXIMITY CARD; AND AMENDING ARTICLE VI – RETURN OF PROPERTY HEARINGS, BY REPEALING SECTION 60-33-26 - NOTICE AND PUBLICATION FEES; AND PROVIDING FOR AN EFFECTIVE DATE.

**ORDINANCE**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

**SECTION 1.** That Section 60-33-11 of Article III of Title 33 of Chapter 60 of the Oklahoma City Municipal Code, 2020, is hereby amended to read as follows:

**CHAPTER 60**

**GENERAL SCHEDULE OF FEES**

**Article III. - Court Procedure**

**§ 60-33-11. - Court costs.**

- (a) court costs per conviction (jury division)
  - 1) driving under the influence of alcohol or other intoxicating substance ....\$283.00
  - 2) all other jury division ....~~83.00~~ 93.00
- (b) for the services of a court reporter at each trial or hearing held in the jury division and non-jury division ..... 20.00
- (c) cost each time a jury trial is requested .... 30.00

- (d) cost each continuance requested by and granted to defendant—Non-jury division .... ~~15.00~~ 30.00
- (e) cost each continuance requested by and granted to defendant—Jury division .... ~~15.00~~ 30.00
- (f) cost payable each month by probationer as court costs during the probationary period .... 40.00
- (g) ~~cost payable by probationer at time of assessment and evaluation .... 175.00~~
- (h) court costs for processing dismissal of charge upon meeting the requirements of the court of record (including deferred sentence), non-jury division:
  - 1) exceeding the speed limit by at least one mile per hour but not more than ten miles per hour .... 77.00
  - 2) all other traffic violations .... 88.00
  - 3) all other non-jury criminal violations .... 83.00
- (i) court costs per conviction—Court of record, non-jury division:
  - 1) exceeding the speed limit by at least one mile per hour but not more than ten miles per hour .... 77.00
  - 2) all other traffic violations .... 88.00
  - 3) all other non-jury criminal violations .... 83.00
  - 4) all parking citations other than handicap parking citations .... 5.00
- (j) fee for issuance of a warrant .... ~~20.00~~ 50.00
- (k) striking a case from jury call docket .... 15.00
- (l) striking a case from non-jury docket .... 15.00
- (m) pre-sentence interview .... ~~15.00~~ 150.00
- (n) administrative fee for continued/deferred sentences not to exceed .... 100.00
- (o) Court case(s) referred to a collection agency shall have a collection agency fee, not to exceed the actual fee charged by the collection agency, assessed as a cost in the respective case.
- (p) court costs to process dismissal on a second or subsequent citation for failure to display current handicap placard upon proof of possession of valid, current handicap placard in a calendar year.... 30.00
- (q) court costs to process dismissal on a second or subsequent citation issued for an expired handicap placard in a calendar year .... 30.00

**SECTION 2.** That Article IV of Title 33 of Chapter 60 of the Oklahoma City Municipal Code, 2020, is hereby amended by the enactment of Section 60-33-16 to read as follows:

**CHAPTER 60**  
**GENERAL SCHEDULE OF FEES**

**Article IV. - Court Operations Division**

**§ 60-33-16. - Fees for Oklahoma City Municipal Courthouse Attorney proximity card.**

- (a) first time Attorney application .... \$ 50.00
- (b) yearly renewal .... 40.00

§§ 60-33-~~16~~17 - 60-33-20. - Reserved.

**SECTION 3.** That Section 60-33-26 of Article VI of Title 33 of Chapter 60 of the Oklahoma City Municipal Code, 2020, is hereby repealed in its entirety.

**SECTION 4. EFFECTIVE DATE.** That the provisions of this ordinance shall become effective on July 1, 2024.
