Joint Resolution with The City of Oklahoma City authorizing the Risk Manager and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM- (to be determined) styled: *Sarah Fullerton-Corpus, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, Sarah Fullerton-Corpus is a 40-year-old female and is a five-year employee of The City of Oklahoma City. At the time of the injury, she was assigned in the Fire Department as a Fire Fighter and continues to be employed by the City.

On August 29, 2020, Claimant sustained an undisputed accidental injury to her left knee.

Claimant required surgeries to repair her left knee on October 8, 2020, and December 1, 2021.

Claimant was evaluated by Dr. Zakary Knutson, M.D., on behalf of the City and found to have the following permanent partial impairment: 2% to the left knee.

The negotiated Joint Petition Settlement calls for a lump sum of \$15,400 for the following permanent partial disability: 16% to the left knee.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$462 be deducted and paid for the Multiple Injury Trust Fund Tax, making the lump sum award \$14,938. In addition, the City will pay Court costs of \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$115.50 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$308.
