

RESOLUTION DECLARING A 2013 E-ONE MOBILE WATER TANKER OBSOLETE AND SURPLUS TO THE NEEDS OF THE FIRE DEPARTMENT AND AUTHORIZING DONATION TO THE ARCADIA FIRE DEPARTMENT.

WHEREAS, the Fire Department has identified a 2013 E-One Mobile Water Tanker to be obsolete and surplus to the needs of the department; equipment number 1354272 (Attachment A; and

WHEREAS, this vehicle has been replaced through the Fire Department's apparatus replacement plan; and

WHEREAS, donating the vehicle to the Arcadia Fire Department in Oklahoma County will benefit their department greatly as the Town of Arcadia is a mutual aid partner and has the potential to respond in coordination with multiple Oklahoma City fire stations; and

WHEREAS, the City will receive a signed release from the Arcadia Fire Department indemnifying the City of Oklahoma City from any liability upon approval of the donation; and

WHEREAS, staff requests Council declare the vehicle as surplus and authorize donation to the Arcadia Fire Department; and

WHEREAS, there is a continuing need for disposal of certain surplus equipment.

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that they do hereby declare the 2013 E-One Mobile Water Tanker surplus, and authorizing donation of vehicle to the Arcadia Fire Department.

SUBJECT: Surplus donation of 3000-gallon mobile water tanker to Arcadia Oklahoma
Fire Department

Fire Chief Davis of the Town of Arcadia made a formal request for the donation of a mobile water tanker from OKCFD. The Town of Arcadia has one mobile water tanker that is over 30 years old and is no longer economically viable to maintain.

OKCFD procured a new water tanker last year to replace unit 1354272, a 2013 E-ONE 3000-gallon mobile water tanker and has deemed the old vehicle as surplus equipment. Fire Department staff believes that donating the surplus mobile water tanker to the Town of Arcadia provides greater value to the City due to the positive ISO score impact for the City. Arcadia Fire is a mutual aid fire department and could be called upon to support water shuttle operations with OKCFD.

Estimated value of unit 1354272 at auction \$30,000-\$40,000.
