

**APPLICATION FOR PRIVATELY CONSTRUCTED
OVERSIZED SANITARY SEWER MAIN EXTENSION
POLICY “B-1” PROJECT NUMBER SB-2021-00002**

This Application by City of Midwest City (“Developer”) for inclusion in the Policy “B-1” for Privately Constructed Oversized Sanitary Sewer Main Extension Project Midwest City Sports Complex (“Project”). **SB-2021-00002**

1. The Developer acknowledges that it has read and fully understands Sanitary Sewer Main Extension Policy “B-1”, as amended (“Policy”); the Procedure for Sanitary Sewer Main Extension Under Policy “B-1”, as amended (“Procedure”); this Application for Private Construction of Oversized Sanitary Sewer Main Extension (“Application”) and the Special Warranty Deed for Transfer of Privately Constructed Oversized Sanitary Sewer Main Extension (“Special Warranty Deed”).
2. The Developer acknowledge that the Oversized Sanitary Sewer Main Extension (“Project”) shall be constructed in accordance with Oklahoma City Water Utilities Trust (“OCWUT”) and City of Oklahoma City (“Oklahoma City”) standards and in a size and location as set forth in by the master plan adopted by the Oklahoma City and OCWUT unless otherwise approved in writing by the General Manager of the OCWUT and the City Manager of Oklahoma City prior to submission of this Application. The Developer acknowledges that the Project shall be constructed at the sole cost and expense of the Developer.
3. The Developer acknowledges that Developer shall not be entitled to any recovery of costs and expenses for the private construction of this Project pursuant to or as a result of the submission or the receipt of this Application. The OCWUT and Oklahoma City have assigned the Project a number for purposes of tracking only.
4. The Developer has attached to this Application completed plans and specifications for the Project approved by the City Engineer and the Director of Water and Wastewater Utilities. The Developer affirms that all required easements have been obtained on approved Oklahoma City forms or in a format approved by Oklahoma City in accordance with established policies, practices, and procedures. The Developer acknowledges that nothing herein shall act to waive any ordinance requirement or to release or absolve the Developer or this Project from any ordinances, permits, or other requirements of Oklahoma City or OCWUT.
5. The approved plans and specifications and easements for this Project are on file with the City Clerk’s Office for Oklahoma City and are incorporated herein by reference.

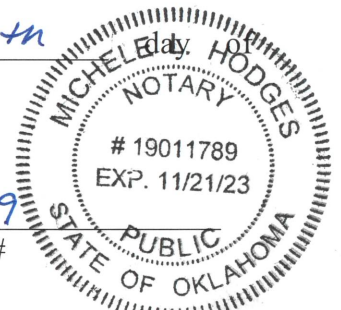
