RE: Project M4-TTE10, MAPS 4 Bus Stop Improvements Phase 1 – Change Order No. 2 and Amendment No.2

## **Background**

The scope of this project is to improve bus stops by providing ADA compliant concrete pads for shelters, lighted shelters, benches, bike racks, trash cans, and ADA access to the bus stops. During the course of the project, various changes to the project will be required. They will include Engineer and Contractor generated items. These items will generally modify functional considerations, add or delete materials and systems, and clarify design intent.

## **Purpose**

The purpose of this change order and amendment is to add, modify or delete items related to the project scope of work. Detailed information on each item is included in the item descriptions.

## **Justification**

This change order and amendment is necessary to formally incorporate the recommended scope of work modifications into the construction contract. More detailed information on each item is included in the item descriptions.

## **Cost**

The total cost for adding or deleting labor and /or materials are summarized below. The complete cost breakdown is included on the attached pricing proposals.

## **Summary of Change Order No. 2 Costs**

Item No. 1: Manhole Adjustments

Purpose: To modify manhole height at eight (8) locations.

Justification: Adjustment of manholes to accommodate grade changes to meet ADA compliance.

Description: Adjustment of eight (8) manholes at \$1,500 each.

Total Cost: \$12,000

**Summary of Amendment No. 2 Costs**

Item No. 1: Amend summary of Pay Quantities.

The total for Change Order No. 2 is \$12,000, which represents an increase of 1.3% over the original contract amount of \$926,234.50. The total for Amendment No. 2 is \$74,025. The total for Change Order No. 2 and Amendment No. 2 is \$86,025. The total for Change Order Nos. 1 and 2 is \$12,900, which represents an increase of 1.4% over the original contract amount. The total for Change Order Nos. 1 and 2 and Amendment Nos. 1 and 2 is \$366,218. The new contract amount is \$1,292,452.50

**Time**

The Change Order does not change the contract time. The completion date by contract remains April 16, 2025.
