KNOW ALL MEN BY THESE PRESENTS THAT THE CITY OF OKLAHOMA CITY, a municipal corporation, and the OKLAHOMA CITY PUBLIC PROPERTY AUTHORITY, an Oklahoma public trust, ("Grantor") for and in consideration of Ten Dollars and other good and valuable consideration, receipt of which is hereby acknowledged, does hereby grant and convey unto the OKLAHOMA CITY WATER UTILITIES TRUST, an Oklahoma public trust, its successors, and assigns ("Grantee") a Permanent Easement over, under, across, through and to the following described property situated in Oklahoma County, Oklahoma, to wit:

See Attachment "A" (Subject Property)

for the purpose of constructing, operating, maintaining, repairing, expanding, and replacing water and wastewater systems and associated facilities, connections, utilities, and appurtenances thereto (collectively "Utility System") and including the right of ingress and egress through Grantor's property to and from the Subject Property and all right, title and interest in and to any soil, earthen material, fixture, and appurtenances within the boundaries of the Subject Property incidentally removed during the use of this easement.

Said easement shall be perpetual and exclusive to Grantee and shall run in favor of the respective parties, hereto, its successors and assigns.

ATTACHMENT "A"

LEGAL DESCRIPTION

A tract of land lying in the Northeast Quarter (NE/4) of Section Thirty-Six (36), Township Twelve (12) North, Range Four (4) West of the Indian Meridian, Oklahoma City, Oklahoma County, Oklahoma being more particularly described as follows:

COMMENCING at the northwest corner of said NE/4;

THENCE South 89°47'32" East, along the north line of said NE/4, a distance of 170.63 feet;

THENCE South 00°12'28" West, perpendicular to said north line, a distance of 167.64 feet to the POINT OF BEGINNING;

THENCE North 78°57'08" East a distance of 634.39 feet;

THENCE South 81°04'42" East a distance of 340.67 feet;

THENCE North 00°04'12" West a distance of 62.42 feet to a point on the south Statutory Right-of-Way line for Northwest 10th Street;

THENCE South 89°47'32" East, along said south Statutory Right-of-Way line, a distance of 30.00 feet;

THENCE South 00°04'12" East a distance of 700.47 feet;

THENCE South 89°55'48" West a distance of 30.00 feet;

THENCE North 00°04'12" West a distance of 607.82 feet;

THENCE North 81°04'42" West a distance of 340.14 feet;

THENCE South 78°57'08" West a distance of 629.11 feet;

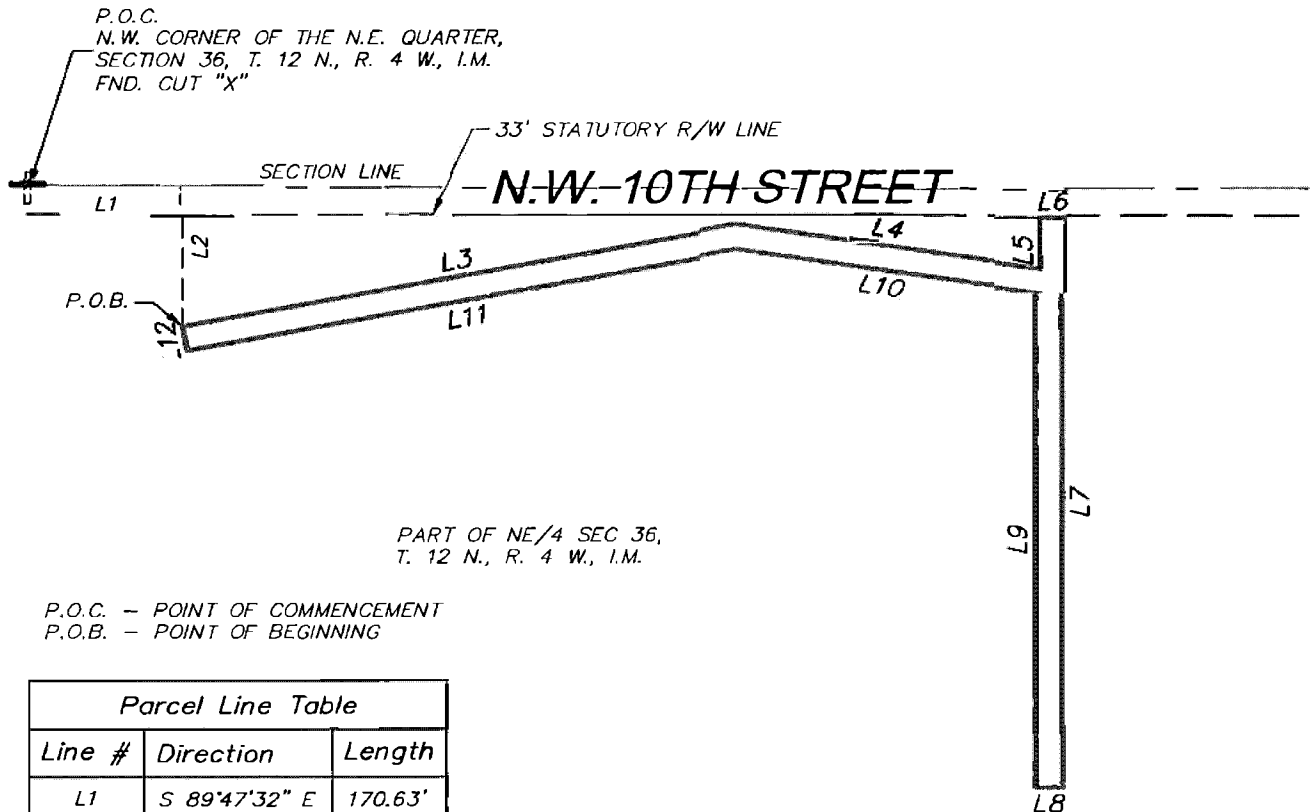
THENCE North 11°02'52" West a distance of 30.00 feet to the POINT OF BEGINNING.

Said tract of land contains an area of 50,181 square feet or 1.1520 acres, more or less.

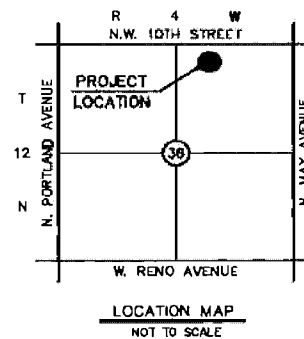
