

**RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST RATIFYING THE ACTIONS OF THE GENERAL MANAGER IN WAIVING COMPETITIVE BIDDING AND ISSUING EMERGENCY PURCHASE ORDER EPO01052024SMK06 TO RANGELINE UTILITY SERVICES, LLC FOR A MAIN BREAK REPAIR AT NW 12TH STREET AND PENNSYLVANIA AVENUE, \$246,000.**

**WHEREAS**, The City of Oklahoma City (City) owns and operates, and the Oklahoma City Water Utilities Trust (OCWUT) leases and finances the Oklahoma City water system; and

**WHEREAS**, OCWUT purchases equipment and materials necessary for the continuous and efficient operation of the City water system; and

**WHEREAS**, on January 4, 2024, a water main break was discovered and crews were unable to make necessary repairs; and

**WHEREAS**, On January 5, 2024, a request was submitted to the OCWUT General Manager to authorize an emergency purchase order for Rangeline Utility Services, LLC; and

**WHEREAS**, the contractor performed a line stop and installed a valve on the 20-inch main at NW 10th Street and Pennsylvania Avenue so that utility crews could repair the main break; and

**WHEREAS**, the line stop was removed by the contractor after the valve was installed; and

**WHEREAS**, it was in the best interest of the public health, safety, and welfare that repairs be done timely to restore the operational capacity in the area; and

**WHEREAS**, the General Manager issued an emergency purchase order; and

**WHEREAS**, the emergency purchase order in the amount of \$246,000 was awarded by the General Manager to Rangeline Utility Services, LLC.

**NOW, THEREFORE, BE IT RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify the actions of the General Manager in waiving competitive bidding and issuing emergency purchase order EPO01052024SMK06 to Rangeline Utility Services, LLC for a main break repair at NW 12th Street and Pennsylvania Avenue, \$246,000.
