

**RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST EXTENDING TIME TO AWARD CONTRACT, AWARDING CONTRACT TO CIMARRON CONSTRUCTION COMPANY, LLC, PROJECT WC-0974-2, WATERLINE REPLACEMENT, VILLA AVENUE TO VIRGINIA AVENUE FROM NW 33RD STREET TO NW 28TH STREET AND CLASSEN BOULVEARD TO WESTERN AVENUE FROM NW 51ST STREET TO NW 46TH STREET, \$7,174,730; AND APPROVING THE CONTRACT AND BONDS.**

**WHEREAS**, Project WC-0974-2 installs waterlines due to deterioration; and

**WHEREAS**, the Oklahoma City Water Utilities Trust (OCWUT) has advertised and received bids for Project WC-0974-2; and

**WHEREAS**, the Public Competitive Bidding Act of 1974 states that a contract for construction of a public improvement must be awarded within 30 days or within 45 days for good cause shown or within 120 days upon mutual agreement between the lowest responsible bidder and the awarding public agency or agencies; and

**WHEREAS**, it is the desire of OCWUT to award the contract to the lowest and best responsible bidder; and

**WHEREAS**, the bids were opened on December 13, 2023; and

**WHEREAS**, this contract was delayed due to necessary review period requirements and the meeting schedule of the Oklahoma City Water Utilities Trust; therefore, preventing award within 30 days of receipt of bids; and

**WHEREAS**, a letter agreeing to honor the bid for 60 days has been received from Cimarron Construction Company, LLC.

**NOW, THEREFORE, BE IT RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby extend time to award contract, award contract to Cimarron Construction Company, LLC, Project WC-0974-2, Waterline Replacement, Villa Avenue to Virginia Avenue from NW 33rd Street to NW 28th Street and Classen Boulevard to Western Avenue from NW 51st Street to NW 46th Street, \$7,174,730; and approve the Contract and Bonds.
