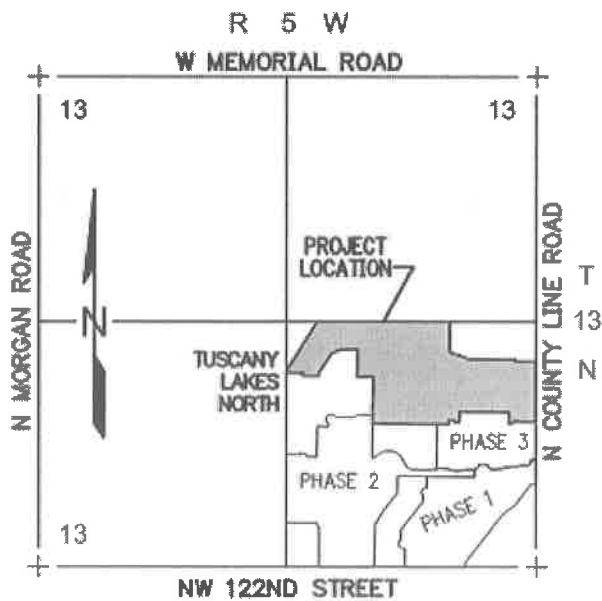

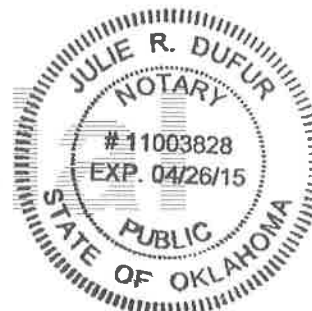

MEMORANDUM OF TRUST

KNOW ALL MEN BY THESE PRESENTS THAT:

1. In consideration of Ten Dollars (\$10.00) and other good and valuable consideration, Harold J. McConnell, an individual of Yukon, Canadian County, State of Oklahoma, as "Trustor," on the 29th day of August, 1989, made, entered into, signed and executed a certain trust agreement and indenture of trust identified as THE HAROLD J. McCONNELL REVOCABLE TRUST.

2. ARTICLE VII, Appointment of Successor Trustee/s, of said Trust provides, in pertinent part, as follows:

7.01 From the creation of this trust and the date of this agreement, Trustor shall serve as Trustee of the trust estate hereby created and during his lifetime, Trustor shall appoint and remove all successor Trustees.

7.02 In the event of total disability of Trustor, either mental or physical, JO ANN McCONNELL and JEFFERY HAROLD McCONNELL shall serve as co-Trustees during the period of Trustor's said disability

7.03 After the death of Trustor, JEFFERY HAROLD McCONNELL is hereby appointed successor Trustee of the trust hereby created, effective upon acceptance of the duties of trusteeship.

3. ARTICLE VI, Provisions Regarding the Initial and/or Successor Trustee/s, paragraph 6.04, provides as follows:

6.04 any successor Trustee shall have, from and after appointment or succession to office hereunder and without any assignment or action by any person, all of the title, rights, interests and powers, including discretionary rights and powers which are by the provisions of this trust granted to and vested in the predecessor Trustee.


