**ORDINANCE ESTABLISHING RESERVED PARKING SPACES FOR THE PHYSICALLY DISABLED ON NORTH LOTTIE AVENUE BETWEEN NE 13TH STREET AND NE 23RD STREET AS FOLLOWS:**

- A. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 41 FEET NORTH TO 68 FEET NORTH OF THE NORTH CURB LINE OF NE 14TH STREET;**
- B. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 32 FEET NORTH TO 59 FEET NORTH OF THE NORTH CURB LINE OF NE 15TH STREET;**
- C. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 48 FEET SOUTH TO 75 FEET SOUTH OF THE SOUTH CURB LINE OF NE 17TH STREET;**
- D. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 138 FEET NORTH TO 165 FEET NORTH OF THE NORTH CURB LINE OF NE 17TH STREET;**
- E. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 98 FEET SOUTH TO 125 FEET SOUTH OF THE SOUTH CURB LINE OF NE 19TH STREET;**
- F. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 31 FEET NORTH TO 58 FEET NORTH OF THE NORTH CURB LINE OF NE 20TH STREET;**
- G. ON THE EAST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 36 FEET NORTH TO 63 FEET NORTH OF THE NORTH CURB LINE OF NE 21ST STREET;**
- H. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 33 FEET SOUTH TO 63 FEET SOUTH OF THE SOUTH CURB LINE OF NE 23RD STREET;**
- I. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 30 FEET NORTH TO 57 FEET NORTH OF THE NORTH CURB LINE OF NE 20TH STREET;**
- J. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 43 FEET NORTH TO 70 FEET NORTH OF THE NORTH CURB LINE OF NE 17TH STREET;**
- K. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 56 FEET NORTH TO 83 FEET NORTH OF THE NORTH CURB LINE OF NE 16TH STREET;**
- L. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 35 FEET NORTH TO 62 FEET NORTH OF THE NORTH CURB LINE OF NE 15TH STREET;**

M. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 42 FEET NORTH TO 69 FEET NORTH OF THE NORTH CURB LINE OF NE 14TH STREET; AND  
N. ON THE WEST SIDE OF NORTH LOTTIE AVENUE FROM APPROXIMATELY 91 FEET NORTH TO 118 FEET NORTH OF THE NORTH CURB LINE OF NE 13TH STREET.

**ORDINANCE**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:**

**SECTION 1. Reserved Parking.** 14 reserved parking spaces for the physically disabled on North Lottie Avenue between NE 13th Street and NE 23rd Street shall be established.

**SECTION 2. REPEALER.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.
