## The City of OKLAHOMA CITY

Approve unlisted Project TC-0629, Traffic Striping; and a total allocation of Unlisted, Interest and Surplus General Obligation Bond Funds from Proposition 3 of the 2007 and 2017 General Obligation Bond Authorizations in the amount of \$232,400. Wards 1, 2, 3, 4, 5, 6, 7 and 8.

**Background:**

Annually, the City of Oklahoma City maintains a unit price contract designed to facilitate essential installation of traffic striping throughout the entire city on an as-needed basis. This comprehensive contract not only addresses traffic striping related to bicycle infrastructure but also extends to various infrastructure projects citywide. In July 2023, the city initiated the advertising phase for this contract, concurrently finalizing specifications and establishing unit prices for the work associated with traffic striping. As the need for traffic striping arises, work orders will be issued under this contract, with Engineering services provided by Public Works staff as required. This allocation request utilizes Unlisted General Obligation Bond and Interest funds to ensure the city can promptly address and successfully maintain the traffic striping system citywide.
