

The following is a scope of work for listed address for a detached garage, new construction

- Build on site a two story 14' x 18' addition to south east corner to match existing house in materials, looks, and design
- New addition installed in back yard as shown on site plans.
  - 14'x18' roof will be 8/12 pitch will place overall height just below existing peak at tie in. Shingles to match existing house, Timberline HD architectural grade shingle. Add low profile vents per required by local code, vents to be painted same color as the shingles. (See roofing attachment for more information)
- Slab and framing
  - Standard spread footings and 4" reinforced slab in accordance with local and city code
  - Standard framing in accordance with local and city code.
- Siding
  - All proposed siding: Hardie Fiber Cement Plank overlap with 7" exposure. Fastened per manufacture specs.
  - 2 corners will have vertical Hardie fiber cement trim (5/4" x 3.5") that the siding plank will butt into. Trim has no wood grain. Trim fastened per manufacture specs.
  - The east wall will be recessed from existing wall by 3"
- Entry door and windows
  - Entry door
    - Rouge Valley Door (manufacture) all wood door. Doug Fir all wood door, 2 lower panel and one large glass panel above with 9 light (wood dividers). All wood (pine) jamb and pine brick mold to frame in. Door glass has inserted dividers between the panels and wood overlay on the interior and exterior sides. please see attached door folder for additional information
  - Windows
    - Manufactured by Quaker Residential Windows and Doors. 2 3x5 window units. White pine window, exterior aluminum clad black to match existing house. Dividing light (also wood with aluminum clad) to match house. New construction nail fins, windows will be

installed before siding. Windows to be trimmed out in same Hardie Fiber Cement Trim as used on garage corners. Please see attached window folder for additional information.












