

ASSIGNMENT

This Assignment of the Professional Services Agreement, C179016 for recycling services and contamination collection and disposal of solid waste from City-owned facilities ("Contract"), by and between the Oklahoma City Environmental Assistance Trust ("OCEAT"), and Waste Management of Oklahoma, Inc. (Contractor") assigns all rights, obligations and duties of the OCEAT from the OCEAT to the Oklahoma City Water Utilities Trust ("OCWUT").

WITNESSETH:

WHEREAS, the OCEAT and the Contractor entered into the attached Contract; and

WHEREAS, upon the formal action of the OCWUT, the water, wastewater and solid waste management systems of the City of Oklahoma City will be consolidated into the OCWUT; and

WHEREAS, the OCEAT, Contractor and the OCWUT desire to assign all rights, obligations and duties owing to or owed by the OCEAT be assigned from the OCEAT to the OCWUT; and

NOW, THEREFORE, the parties agree as follows:

1. The OCEAT hereby assigns and the OCWUT hereby accepts the assignment of all rights, obligations and duties in and under the Contract.
2. The Contractor consents and approves the assignment of all rights, obligations and duties in and under the Contract from the OCEAT to the OCWUT.
3. This Assignment will be effective on the date of the transfer and consolidation of the water, wastewater and solid waste management systems into the OCWUT as reflected in the actions of the OCWUT.
