## ASSIGNMENT

This Assignment of the Professional Services Agreement, C189013 for solid waste fleet management services ("Contract"), by and between the Oklahoma City Environmental Assistance Trust ("OCEAT"), and First Vehicle Services, Inc. - 3. This Assignment will be effective on the date of the transfer and consolidation of the water, wastewater and solid waste management systems into the OCWUT as reflected in the actions of the OCWUT.
