## **ASSIGNMENT**

- 1. The OCEAT hereby assigns and the OCWUT hereby accepts the assignment of all rights, obligations and duties in and under the Contract.
- 2. The Contractor consents and approves the assignment of all rights, obligations and duties in and under the Contract from the OCEAT to the OCWUT.
- 3. This Assignment will be effective on the date of the transfer and consolidation of the water, wastewater and solid waste management systems into the OCWUT as reflected in the actions of the OCWUT.
