

**RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST RATIFYING THE ACTIONS OF THE GENERAL MANAGER IN DECLARING AN EMERGENCY, APPROVING THE BIDDING DOCUMENTS, APPROVING ADDENDUM NO. 1, AND AWARDING A CONTRACT TO URBAN CONTRACTORS, LLC, PROJECT SE-0043, EMERGENCY SANITARY SEWER REPAIRS, SW 29TH STREET FROM MERIDIAN AVENUE TO UTAH AVENUE, \$249,140; RATIFYING ISSUANCE OF AN EMERGENCY WORK ORDER; AND APPROVING THE CONTRACT AND BONDS.**

**WHEREAS**, the sewer line at the referenced location collapsed and needs to be replaced;  
and

**WHEREAS**, the necessary repairs will include a new sewer main and three manholes;  
and

**WHEREAS**, it is in the best interest of the public health, safety, and welfare that repairs must be done timely to restore the operational capacity of the sanitary sewer system; and

**WHEREAS**, the necessary repairs are beyond the immediate resources of the Oklahoma City Line Maintenance Division; and

**WHEREAS**, the General Manager declared an emergency to exist; and

**WHEREAS**, bidding documents were prepared for Project SE-0043, emergency sanitary sewer repairs, SW 29th Street from Meridian Avenue to Utah Avenue; and

**WHEREAS**, Urban Contractors, LLC, with a sealed bid in the amount of \$249,140, was determined to be the lowest responsible bidder for Project SE-0043; and

**WHEREAS**, the emergency contract for Project SE-0043 in the amount of \$249,140 was awarded by the General Manager to Urban Contractors, LLC; and

**WHEREAS**, Urban Contractors, LLC has signed the contract and bonds for Project SE-0043 for the bid amount of \$249,140; and

**WHEREAS**, the City Engineer issued an emergency work order.

**NOW, THEREFORE, BE IT RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify the actions of the General Manager in declaring an emergency; approving the bidding documents, approving Addendum No. 1; and awarding a contract to Urban Contractors, LLC, Project SE-0043, emergency sanitary sewer repairs, SW 29th Street from Meridian Avenue to Utah Avenue, \$249,140; and

**BE IT FURTHER RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify issuance of an emergency work order; and

**BE IT FURTHER RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby approve the contract and bonds.

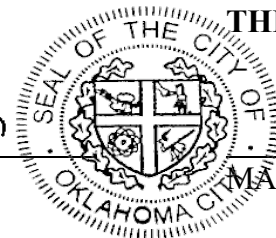
