
Your property is not included within the area proposed to be rezoned. This notice is being provided to you because you own property nearby.

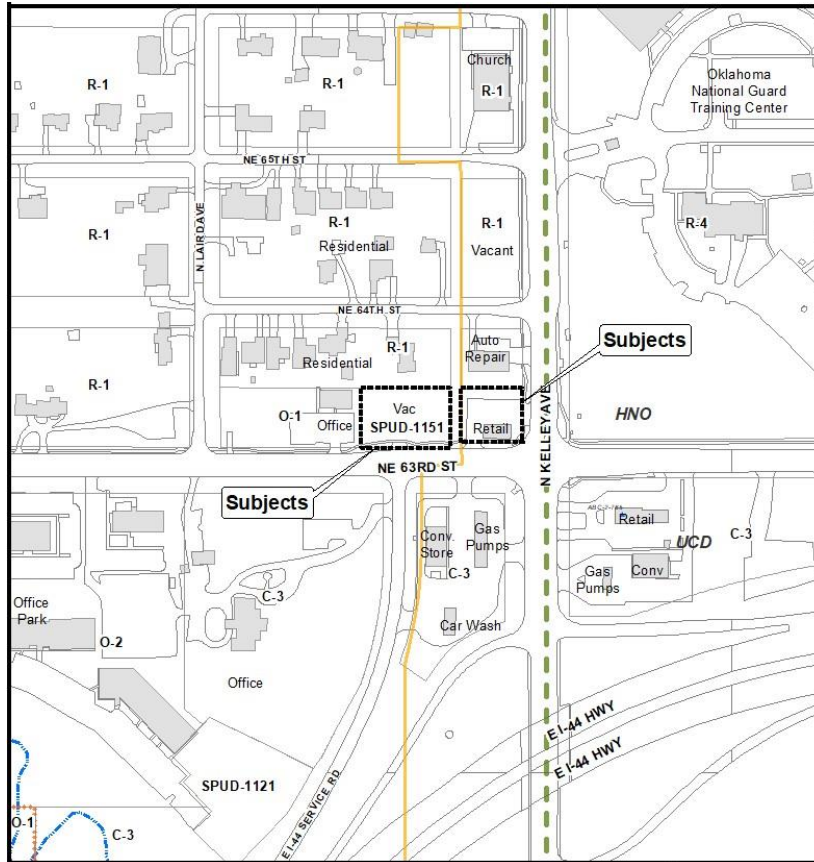

AND The South Half (S/2) of Lots FIVE (5), and all of Lots SIX (6), SEVEN (7), EIGHT (8), and NINE (9), both inclusive, LESS AND EXCEPT the South 10 feet of Lot 9, in Block THIRTY- FIVE (35), of RAVENSWOOD MANOR ADDITION, to Oklahoma City, Oklahoma County, Oklahoma, according to the recorded plat thereof.
