RESOLUTION AUTHORIZING THE CITY OF OKLAHOMA CITY TO ACCEPT A \$800 EMERGENCY MANAGEMENT PERFORMANCE GRANT AMERICAN RESCUE PLAN ACT (EMPG-ARPA) FOR TRAINING/CONFERENCE ATTENDANCE REIMBURSEMENT FROM THE STATE OF OKLAHOMA DEPARTMENT OF EMERGENCY MANAGEMENT AND HOMELAND SECURITY (ODEMHS); AUTHORIZING THE MAYOR TO SIGN ANY NECESSARY DOCUMENTS; AUTHORIZING THE POLICE BUSINESS MANAGER OR MANAGEMENT SPECIALIST TO SUBMIT THE ACCEPTANCE, APPROVE CLAIMS, REQUEST FUNDS, AND PROVIDE REPORTS AS REQUIRED; AND AUTHORIZING THE CITY TREASURER TO RECEIVE AND DEPOSIT THE FUNDS IN THE GRANTS MANAGEMENT FUND.

WHEREAS, The City of Oklahoma City has a comprehensive emergency management program that is the responsibility of the Office of Emergency Management that is a subordinate unit of the Oklahoma City Police Department; and

WHEREAS, the purpose of this agreement is to provide a portion of the funds awarded to the State of Oklahoma under the Federal Emergency Management Agency (FEMA) EMPG-ARPA Program. This project is associated as a special project and encourages the development of a comprehensive emergency preparedness system for all hazards for the State and local governments, as defined by the FEMA Fiscal Year 2021 EMPG Notice of Funding Opportunity (NOFO). ODEMHS Special Projects are designed to encourage local activities that fill gaps and needs in State, Regional, and Local levels of emergency preparedness and readiness; and

WHEREAS, the Training/Conference Attendance Reimbursement Grant Opportunity is designed to reimburse emergency managers of local jurisdictions for attending important training and conference opportunities designated to increase their knowledge and ability to better prepare for and respond to emergencies and disasters within their jurisdictions; and

WHEREAS, the total amount of funds approved for the grant period of January 1, 2022, through September 30, 2022 is \$800. A grant match is not required with this grant.




BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City authorizing the mayor to sign any necessary documents.
