KNOW ALL MEN BY THESE PRESENTS THAT THE CITY OF OKLAHOMA CITY, a municipal corporation, and the OKLAHOMA CITY RIVERFRONT REDEVELOPMENT AUTHORITY, a public trust created and established under the laws of the State of Oklahoma (collectively, "Grantors"), for and in consideration of Ten Dollars and other good and valuable consideration, receipt of which is hereby acknowledged, do hereby grant and convey unto the OKLAHOMA CITY WATER UTILITIES TRUST, a public trust created and established under the laws of the State of Oklahoma, its successors, and assigns ("Grantee") a Permanent Easement over, under, across, through and to the following described property situated in Oklahoma County, Oklahoma, to wit:

for the purpose of constructing, operating, maintaining, repairing, expanding, and replacing water and wastewater systems and associated facilities, connections, utilities, and appurtenances thereto (collectively "utility system") and including the right of ingress and egress through Grantors' property to and from the Subject Property and all right, title and interest in and to any soil, earthen material, fixture, and appurtenances within the boundaries of the Subject Property, incidentally removed during the use of this easement.

Said easement shall be perpetual and exclusive to Grantee and shall run in favor of the respective parties, hereto, its successors and assigns.
