

RESOLUTION AUTHORIZING THE OPEN MARKET PURCHASE OF RENTAL OF CONSTRUCTION, GROUNDS AND GENERATOR/LIGHTING EQUIPMENT NO BID ITEMS AND RELATED ITEMS AND SERVICES NOT AVAILABLE ON A PRICING AGREEMENT (OM23-C218038), ESTIMATED COST \$25,000, JULY 1, 2022 THROUGH JUNE 30, 2023.

WHEREAS, the pricing agreements were originally awarded June 9, 2020 for the period ended June 30, 2021; and

WHEREAS, the pricing agreements were renewed June 8, 2021 for the period ending June 30, 2022; and

WHEREAS, the pricing agreements include two one-year renewal options; and

WHEREAS, this is the second renewal for these pricing agreements; and

WHEREAS, these pricing agreements are being renewed for the period ending June 30, 2023; and

WHEREAS, staff recommends open market authority for the purchase of rental of construction, grounds and generator/lighting equipment no bid items (see attachment) and related items and services not available on a pricing agreement, estimated cost \$25,000, July 1, 2022 through June 30, 2023; and

WHEREAS, purchases made with this authority will comply with the City's open market purchasing procedures; and

WHEREAS, there is a continuing need for the purchase of this commodity.


