Friday kicks off OKC Pridefest with live music on the Main Stage, vendors, food trucks, Youth Zone, Family Zone, a Community Zone, roller-rink and more!

Festival Continues: 9am - 11pm | Saturday, June 26th

Saturday's festivities begin with the OKC Pride Alliance Parade at 10am - 12pm. The parade will step-off at NW Sixth Street and travel South on Walker, turning East on Oklahoma City Boulevard to disband at S Robinson Avenue. Following the parade, the music lineup will begin on the main stage and programming starts throughout the park. Food trucks, vendors, family zone, Pride Alliance HQ, youth zone and more. Saturday evening music continues on the main stage until 11pm.

Festival Concludes: 9am - 4pm | Sunday, June 21st

Sunday is a day of wellness, poetry, entertainment and more. Closing ceremonies at 3pm. Event will begin break-down at 4pm when festival ends.

Parade Start: 10:00am | Saturday, June 25th

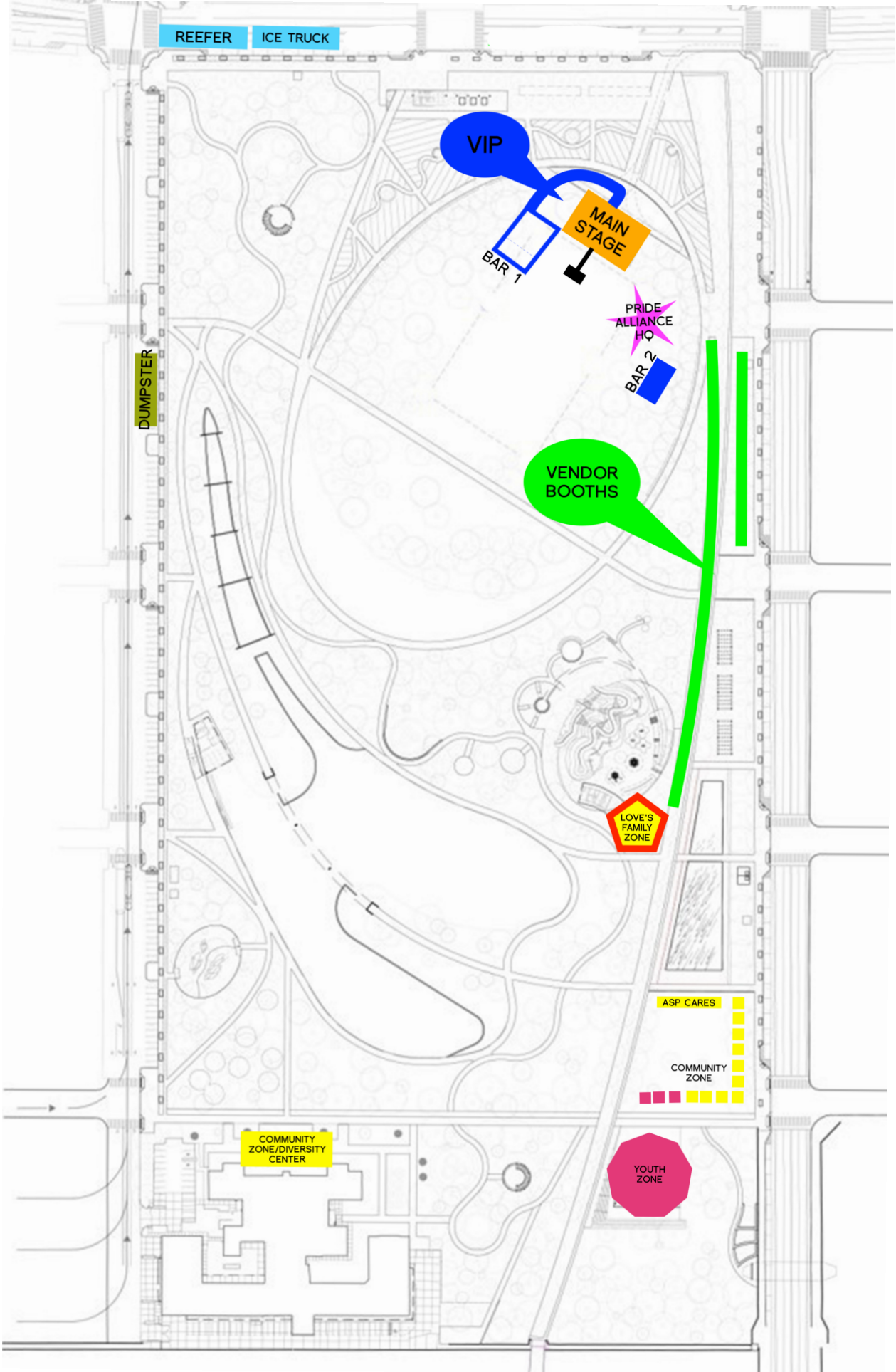

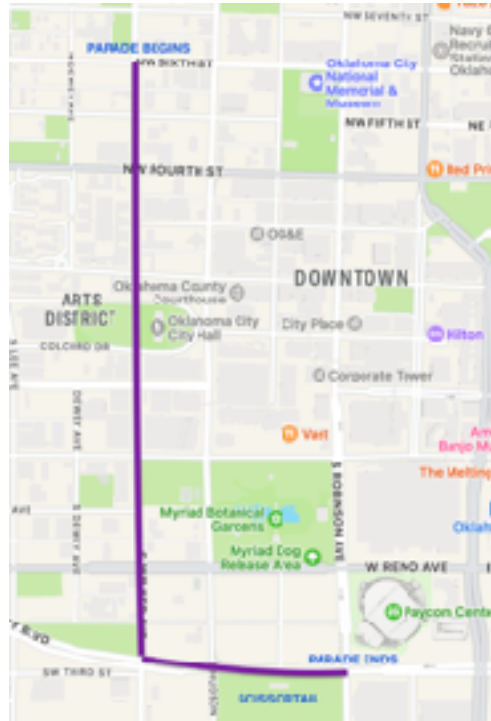

Loading Zone

NW 6th Street, Lee Ave to Walker Ave, including 2 blocks of NW 6th Street. Streets will need to be closed starting at 5:00AM and will be reopened once all corrals have emptied onto parade route.

Loading zone will contain up to 9 corrals. Parade entrants will be assigned a corral based on their position in the parade. Entrants will load corrals at specific loading times assigned prior to the parade. At the start of the parade, corrals will be released onto parade route in numerical order starting with corral #1.

Exit

Parade participants will exit going N on Harvey Ave or N or S on Robinson Ave.

2022 OKC Pride Festival - Parade Traffic Flow Map

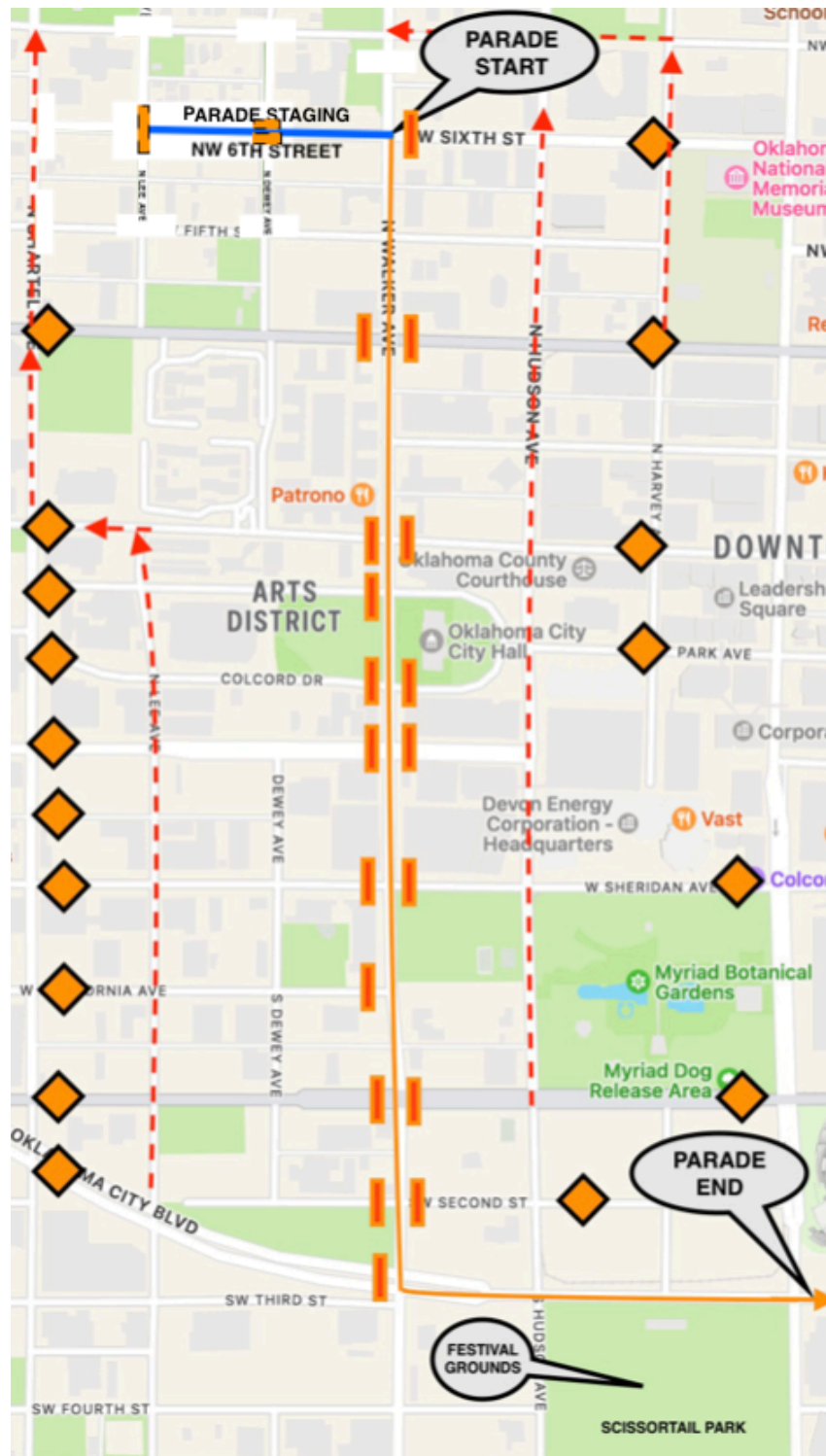
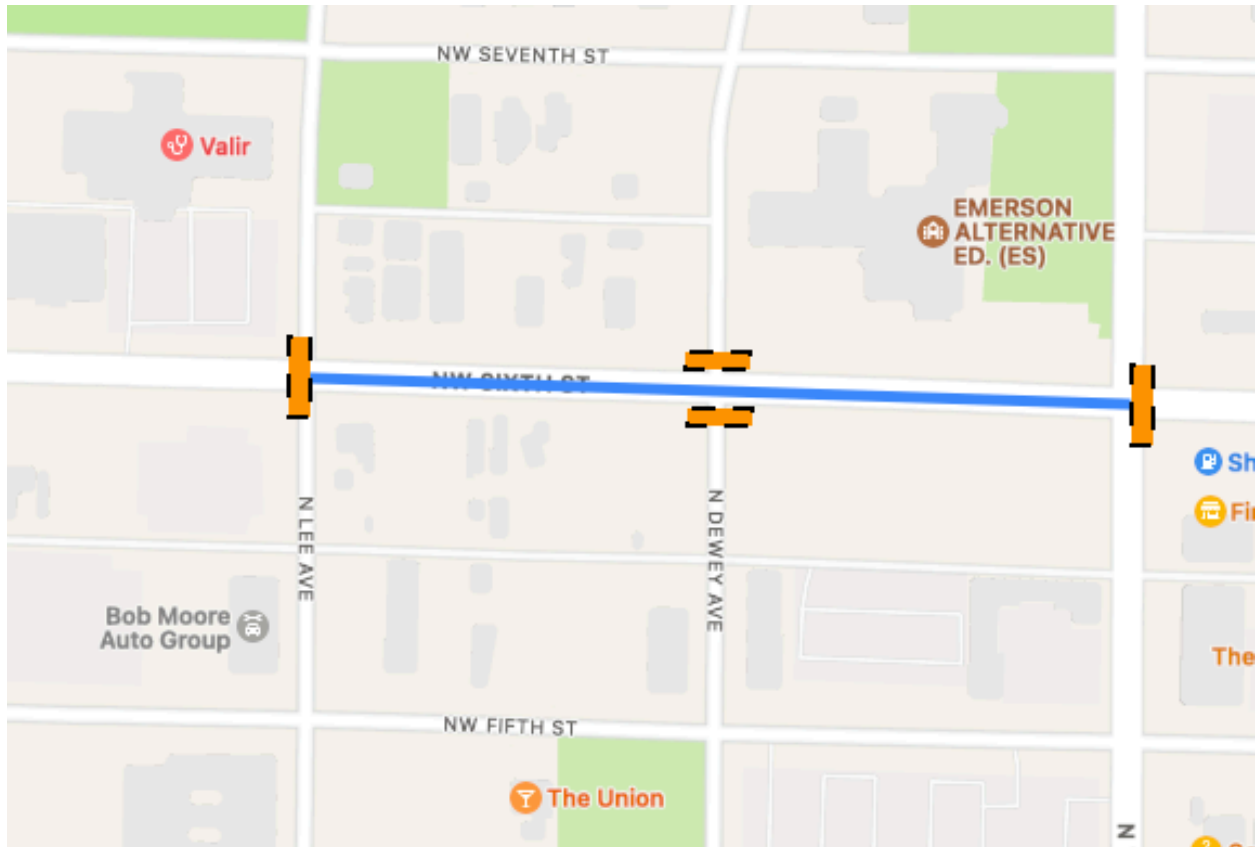
