Claims to Public Entities

Article IX., Section 2-802 of the 2010 Municipal Code provides that signatures can be waived by the Finance Director for claims submitted by public entities with the consent of the Municipal Counselor and the City Auditor. Article IX., Section 2-801 Subsection (a)(5) requires claimants to submit a sworn affidavit that claims submitted are correct and that work, services or materials on the claim have been completed or supplied. Article IX, Section 2-801 Subsection (b)(1) provides that in lieu of the requirements of Article IX., Section 2-801 Subsection (a)(5) described above, a claimant will be required to sign the purchase order issued by the City.

The signature required by Article IX, Section 2-801 Subsection (b)(1) of the 2010 Municipal Code is hereby waived for all claims paid to public entities, including without limitation, federal, state, county, and local government entities, public trusts of which the City is beneficiary, and legal entities of which is a component part.
