XII. Comments from Council

Councilperson Carter said Go Pokes! He noted they play against Central Michigan Thursday night.

Councilperson Hamon noted in light, of the discussion regarding an annexation, the process of how property is annexed into the city limits need to be reconsidered, as it appears that there is not any transparent or open communication with the county. She indicated the issue is that this did not go through another ad hoc annexation committee, even though the previous one happened in years past and things changed. She said this also speaks to the fact that our city is too large, and it is hard to deliver City services adequately; and when we talk about extending water infrastructure and fire coverage, it just means that 20 years down the road, we will have to add bond propositions for new fire stations when we already have lots of needs that are being deferred for decades. She expressed concerns that the land annexation process leaves out the Councilmembers that are in the core of the city, and that it is hard and/or complicated to understand. She indicated she would like to work with other Councilmembers to address how the process is done and make sure that it is transparent and easy to understand.

Councilperson Nice expressed in light, of Councilperson Hamon's comments, that she is still awaiting four streets to be repaved, and there are limitations and barriers in accessing City resources because of the sprawl that we already have, especially within the 130 square miles of area that she personally serves.

Councilperson Nice commended the Riversport Foundation on their amazing event over the weekend. She noted she attended on Friday and Saturday, and although it was hot, people were standing outside watching those kayaks float down the river; it was fun. She indicated they plan to broadcast the International Canoe Federation Paddle Sport event in Europe. She said she was very excited and pleased with what she saw; the diversity of people in all the countries that were represented, was amazing and beautiful. She believes the event will come back to Oklahoma City again and she is excited about that.

Councilperson Nice thanked the Chamber of Commerce for their trip to Milwaukee, Minnesota to experience and understand the development that is happening there. She noted their Mayor, who is the first African American to be elected in that capacity for the City of Milwaukee, was a part of the conversation as well. She said it was nice to see that type of history in that space. She noted they also got to tour the arena, including the locker rooms, where Giannis Antetokoumpo and Serge Ibaka play. She said she looks forward to the conversation of how we look forward and the community benefit agreements that could possibly come with it.


