

RESOLUTION RATIFYING ADVERTISEMENT OF A REQUEST FOR PROPOSAL RFP23305; AND APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH POINT MADE LEARNING, LLC (C233008) FOR THE PURCHASE OF AN EXPERIENCE-BASED LEARNING ACTIVITY THAT EDUCATES WORKING PROFESSIONALS ON THE INCLUSION AND DIVERSITY BUSINESS CASE, ESTIMATED COST \$65,500, SEPTEMBER 27, 2022 THROUGH SEPTEMBER 26, 2024.

WHEREAS, on March 16, 2022 (Item No. IX.J), the City Council approved the release of a Request for Proposals (RFP23305) for the purchase of an experience-based learning activity that educates working professionals on the Inclusion and Diversity business case; and

WHEREAS, on April 13, 2022, the City received five proposals; and

WHEREAS, after reviewing the presentations, the evaluation committee unanimously rated Point Made Learning, LLC's presentation exceeding the requirements of the RFP; and

WHEREAS, the RFP evaluation committee reviewed and evaluated the five proposals and determined the proposal submitted by Point Made Learning, LLC best met the requirements of the RFP; and

WHEREAS, OCMFA funds will be used for purchases from this agreement; and

WHEREAS, the Oklahoma City Municipal Facilities Authority is ratifying the advertisement of the RFP and approving the agreement, allowing staff to enter into a two-year agreement; and

WHEREAS, staff is requesting the Oklahoma City Municipal Facilities Authority (OCMFA) ratify the advertisement of RFP23305 and approve a Professional Services Agreement with Point Made Learning, LLC to provide an experienced-based learning activity and training, estimated cost \$65,500, September 27, 2022 through September 26, 2022.

NOW, THEREFORE, BE IT RESOLVED by the Oklahoma City Municipal Facilities Authority to hereby ratify the advertisement of RFP23305; and approve a Professional Services Agreement with Point Made Learning, LLC to provide an experienced-based learning activity and training, estimated cost \$65,500, September 27, 2022 through September 26, 2024.
