

RESOLUTION

RESOLUTION AUTHORIZING THE ACCEPTANCE OF A \$10,000 GRANT FROM AKC REUNITE; RATIFYING SUBMITTAL OF THE APPLICATION BY THE CHIEF OF POLICE AND THE POLICE DEPARTMENT BUSINESS MANAGER, AUTHORIZING THE MAYOR TO SIGN ANY NECESSARY DOCUMENTS; AUTHORIZING THE POLICE BUSINESS MANAGER OR MANAGEMENT SPECIALIST TO SUBMIT THE ACCEPTANCE, REQUESTS FOR FUNDS, PROVIDE REPORTS AS REQUIRED, AND TO ADMINISTER THE GRANT; AND AUTHORIZING THE CITY TREASURER TO RECEIVE AND DEPOSIT THE FUNDS IN THE GRANTS MANAGEMENT FUND.

WHEREAS, AKC Reunite is working with AKC Clubs to donate K-9 police dogs to police departments around the United States; and

WHEREAS, this grant provides funding of \$10,000 for the purchase of a Critical Incident Response Trained (CIRT) K9 to work as a therapy dog for the Oklahoma City Police Department; and

WHEREAS, the dog is specially trained in Critical Incident Response Training and will be used in wellness, critical incident responses, community relations, recruiting and will provide emotional support for officers, civilians, and victims during critical situations; and

WHEREAS, as included in the grant application, the dog will be purchased from K9's for Freedom; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Oklahoma City that the City is authorized to accept the grant award of \$10,000 from AKC Reunite.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the submittal of the application by the Chief of Police and the Police Department Business Manager is ratified.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of

Oklahoma City that the Mayor is authorized to sign any necessary documents.

BE IT FURTHER RESOLVED by the Mayor and Council of The City of Oklahoma City that the Police Business Manager or Management Specialist are authorized to submit the acceptance, requests for funds, provide reports as required, and administer the grant and the City Treasurer is authorized to receive and deposit these funds into Grants Management Fund 019.
