RESOLUTION OF THE OKLAHOMA CITY PUBLIC PROPERTY AUTHORITY DESIGNATING PRIEFERT RANCH AND RODEO EQUIPMENT AS SOLE SOURCE CONTRACTOR, PROJECT MB-1653, FAIRGROUNDS STALL REPAIRS IN MULTIPLE BARNS, \$89,723.37, AND APPROVING CONTRACT AND BONDS.

WHEREAS, Priefert Ranch and Rodeo has provided the OKLAHOMA CITY PUBLIC PROPERTY AUTHORITY a proposal for repairs to the stalls for:

PROJECT MB-1653, FAIRGROUNDS STALL REPAIRS IN MULTIPLE BARNS

as outlined in the proposal; and

**WHEREAS**, the existing stalls were designed by Priefert Ranch and Rodeo Equipment for Oklahoma State Fair Park to allow them to have removeable walls; and

**WHEREAS** the existing stalls were fabricated and installed by Priefert Ranch and Rodeo Equipment in 2007; and

WHEREAS, the basis for the sole source is to utilize the company that fabricated and installed the original stalls and that has the necessary proprietary parts; and

WHEREAS, City Staff has received a sole source proposal from Priefert Ranch and Rodeo Equipment in the amount of \$89,723.37 for furnishing all labor and materials for Project MB-1653, Fairgrounds Stall Repairs in Multiple Barns; and

WHEREAS, the OCPPA has examined the proposal submitted and has determined and declared the above named Contractor to be designated as the sole source contractor on the above described project.

NOW, THEREFORE, BE IT RESOLVED by the Trustees of the Oklahoma City Public Property Authority that for the reasons stated above, that it is in the best interest of the OCPPA to designate Priefert Ranch and Rodeo Equipment as a sole source contractor, Project MB-1653, Fairgrounds Stall Repairs in multiple barns, located at Oklahoma State Fair Park, \$89,723.37, and approving contract and bonds.
