

RESOLUTION

A RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY ESTABLISHING A DATE FOR THE PROPOSED ENACTMENT OF AN ORDINANCE CLOSING A PUBLIC WAY OR EASEMENT, DETERMINING THOSE ENTITLED TO NOTICE OF SAME, AND DIRECTING THAT SAID NOTICE BE ISSUED.

WHEREAS, an application to close the following described public way or easement has been considered by the Planning Commission of The City of Oklahoma City as part of a Master Plan or amendment of same, to-wit:

A tract of land being a part of the Southeast Quarter (SE/4) of Section Twenty-eight (28) and the Southwest Quarter (SW/4) of Section Twenty-seven (27), Township Twelve (12) North, Range Three (3) West of the Indian Meridian, Oklahoma City, Oklahoma County, Oklahoma, being a portion of NORTH BROADWAY ADDITION recorded in Book 3 of plats, Page 3, being more particularly described as follows: All of Northwest 14th Street as shown on said NORTH BROADWAY ADDITION, lying between Blocks 2 and 3 of said NORTH BROADWAY ADDITION, from the East line of North Broadway Avenue to the West line of Atchison, Topeka and Santa Fe railroad right-of-way, together with the park lines and the strips of land, 30 feet in width, on both sides of said street, which are reserved for park purposes by the plat and declaration for NORTH BROADWAY ADDITION.

WHEREAS, an ordinance closing the same is proposed to be considered by the City Council on the 17th day of January, 2023; and

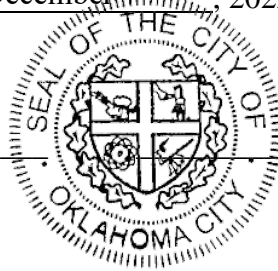
- A. All above listed franchise holders.

- C. All property owners within 300 feet of the public way or easement to be closed whose names appear on the ownership list required to be submitted as a part of this application.

Such notice shall state that an ordinance to close the aforesaid public way or easement has been proposed for enactment on the 17th day of January, 2023. A copy of the resolution shall be included with said written notice.
