1) Replace siding (elective).



JAMES HARDIE INSTALLATION

The following bid is for repairs to your home:

1. Remove all existing siding on left wall, right wall, left and right sides of front dormer from Home.
2. Inspect framing after siding has been removed. Should any framing need to be replaced we will charge an additional fee for this additional work based on labor and material only.
3. Install 1/4" Profold Insulated Sheathing with an R-value 1 on walls where siding has been removed over studs and tape around doors, windows and seams.
4. Install Pre-primed 6 1/4" Smooth Hardie Plank siding with 5" reveal and Smooth Hardie Trim® on all walls and Gables around windows and doors where existing siding was removed using Hardie® approved installation procedures.
5. Install James Hardie trim boards with urethane crown molding to match existing trim as close as possible on walls where new siding is installed on house. *Cedar with Cedar*
6. Repair loose siding on front of dormer.
7. Remove rotted fascia board on upper rear left side of home and replace using James Hardie material Smooth style.
8. Apply Foam Insulation around all windows before installing new siding and trim.
9. Trim around windows using James Hardie Smooth Trim.
10. Clean up the work site of all job-related debris.
11. Issue Warranty on James Hardie Products: 30 years on Hardie Plank® and 15 years on Hardie Trim®. Amazing Siding will warranty labor for Lifetime of original owner.
