

**FIRST AMENDMENT TO THE CITY OF OKLAHOMA CITY BROWNFIELDS  
CLEANUP REVOLVING LOAN FUND GRANT AGREEMENT WITH  
COMMUNITY HEALTH CENTERS, INC.**

THIS AMENDMENT is made this 29TH day of AUGUST, 2023, by and between The City of Oklahoma City and Community Health Centers, Inc. to the grant agreement authorized by the Oklahoma City Council on July 20, 2023, as follows:

This First Amendment corrects the legal description for the property that is the subject of this Agreement but retains all other remaining provisions of the original Agreement between the parties hereto.

A Parcel of land lying in the North Half (N/2) of the Southeast Quarter (SE/4) of Section NINETEEN (19), Township ELEVEN (11) North, Range TWO (2) West of the Indian Meridian, Oklahoma County, Oklahoma, described as follows: Beginning at the Northeast Corner of the West Half of the Northeast Quarter of the Southeast Quarter of Section 19, Township 11 North, Range 2 West; Thence South 0°00'14" West a distance of 600.0 feet; Thence North 89°56'00" West a distance of 820.0 feet; Thence North 0°00' 14" East a distance of 600.0 feet; Thence South 89° 56'00" East a distance of 820.0 feet to the Point of Beginning.
