## The City of OKLAHOMA CITY

Joint Resolution with The City of Oklahoma City authorizing the Risk Manager and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. (to be assigned), styled: *Kevin Wallace, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Kevin Wallace is a 58-year-old male and is a 23-year employee of The City of Oklahoma City. At the time of the injury, he was assigned in the Fire Department as a Corporal and continues to be employed by the City.

On May 1, 2021, Claimant sustained an undisputed accidental injury to his right shoulder. On June 11, 2021, Claimant required surgery on his right shoulder.

The negotiated Joint Petition Settlement calls for a lump sum of \$12,600 for the following permanent partial disability: 10% to the right shoulder.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$378 be deducted and paid to the Multiple Injury Trust Fund Tax, making the lump sum award \$12,222. The settlement further calls for \$2,520 to be deducted from the PPD award and paid in a lump sum to Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Workers' Compensation Court costs of \$140 and \$161 for the District Court; a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$94.50 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$252.
