Ratifying and approving Addenda Nos. 1 and 2; rejecting bids; and approving revised Plans and Specifications to be advertised for bids, Projects PC-0911, PC-0912 and PC-0913R, street resurfacing and repair, SE 74th Street from Santa Fe Avenue to Shields Boulevard, South Pennsylvania Avenue from SW 44th Street to SW 59th Street, SW 15th Street from South Grand Boulevard to South Portland Avenue. Wards 4 and 6.

**Location:**

South Pennsylvania Avenue from SW 44th Street to SW 59th Street  
SW 15th Street from South Grand Boulevard to South Portland Avenue

**Background:**

This 2017 Better Street Safer City projects provides for street resurfacing and repair. The total length of the street covered under this contract is 2.48 centerline miles.

Addendum No. 1 was required to revise the special provisions and clarify the intent of the specifications for two bid items. Addendum No. 2 was required to clarify the specifications for the multiple layer polymer concrete overlay.

Bids were received on October 12, 2022. It is recommended that the bids be rejected because they are over budget. The Public Works Department conducted a thorough review of the bid tabulations and revised the plans and/or specifications, which are being re-submitted for advertisement.

Construction is scheduled to begin early 2023 and be completed in late summer 2023.
