Change Order No. 4 and Amendment No. 2, Project PC-0496 Phase I, Fairgrounds South Parking Lots – Lot A, north of West Reno Avenue and west of Del Mar Gardens Avenue, decrease of \$11,837.69. Ward 6.

### Location:

North of West Reno Avenue and West of Del Mar Gardens Avenue

### Background:

Hotel Motel Tax provides for construction of a new parking lot. Construction of the MAPS 4 Oklahoma State Fairgrounds Coliseum will eliminate 350 parking spaces. These parking spaces are a necessary part of operations at Oklahoma State Fair Park. The construction of this parking lot will add 373 parking spaces. A critical part of the project design was overcoming drainage issues and how to control run-off, and the impact of construction on existing utilities. Access routes from the new parking area were analyzed to ensure public safety.

Construction began in spring of 2022 and was substantially complete in summer of 2022.

Change Order No. 4 provides for the addition of galvanized handrail in drainage areas. Amendment No. 2 provides for adjustments to plan quantities for final as-built quantities for final as-built quantities.

Change Order No. 4 represents an increase of \$23,499.00 or 1.18% above the original contract amount. Amendment No. 2 represents a decrease of \$35,336.69. When Change Order Nos. 1, 2, 3 and 4 are added together, it increases the original contract \$199,194.81 or 9.97%, making the revised contract amount \$2,430,546.51. When Change Order Nos. 1, 2, 3 and 4 and Amendment Nos. 1 and 2 are added together it results in an increase of \$420,532.17 resulting in a revised contract amount of \$2,418,708.82.
