**(C-7284) Final Plat of Montereau Phase 4, being a part of the Northeast Quarter of Section 12, Township 13 North, Range 5 West of the Indian Meridian, located south of NW 150<sup>th</sup> Street and west of N. County Line Road. Ward 8.**

**B. Case History**

This is a new application. The preliminary plat for Montereau II was approved on May 22, 2008.

**C. Reason for Request**

The developer proposes a single-family residential development on this site.

**D. Existing Conditions**

1. **Size of Site:** 15.14 acres

**II. SUMMARY OF APPLICATION**

The developer is proposing 59 single-family residential lots and one common area on 15.14 acres, yielding a gross residential density of 3.90 dwelling units per acre. Public streets, water, and sewer improvements are proposed. The site is currently zoned PUD-1095 which allows for development under the R-1 single-family residential and R-1ZL zero-lot-line residential district regulations. The PUD indicates that minimum lot sizes shall be 6,000 square feet for residential lots. Lots in this subdivision range in size from approximately 7,000 square feet to 12,500 square feet.

Access to this development will be taken from one median-divided connection with Chambord Drive in Montereau Phase 2. This street leads to one median-divided connection with NW 150<sup>th</sup> Street and one median divided connection with N. County Line Road. All streets will be constructed to urban local street standards.

A note on the plat indicates that the maintenance of all common areas and drainage easements are also the responsibility of the property owner's association.

Sidewalks are required to be built on all lots where they abut a local or collector street. These sidewalks are required to be installed at the building permit stage. The developer is also required to install sidewalks along both section-line roads. These sidewalks are required to be installed prior to a certificate of occupancy for any structure within this phase of the development.

**7. Public Works**

a) Engineering **PD-**

1) Streets

- a) All City streets and drives on City right-of-way serving this subdivision must be paved in accordance with City standards.
- b) The subject property is served by a public street.

2) Storm Sewer

- a) The Public Works Drainage Division staff has reviewed the subject application. All development, new construction, and/or substantial improvements planned within the proposed area shall be subject to chapter 16 of the Oklahoma City Municipal Code.
- b) Storm sewers in accordance with the City's Drainage Ordinance will be required. Development abutting section line roads with drainage flows that exceed the capacity of OKC standard ditch detail (D-100) will necessitate the installation of enclosed storm sewer and/or concrete channel. The improvements shall be placed to provide a minimum of 35 feet clearance distance from the centerline of the section. Concrete channels must be entirely outside public right-of-way. Sidewalks shall be constructed in compliance with the Oklahoma City Ordinance and meet all applicable ADA regulations.
- c) A flood and / or drainage study will be required for improvements to establish finished floor elevations, common lot areas or private drainage easements. A final plat should not be submitted until the study has been reviewed and approved by the Public Works Department.
- d) Minimum Finish Floor Elevation will be required for lots by the exiting channel and pond. Based on the 100-year water surface elevation (established from the City of Oklahoma City urbanized study) + 1 foot. The Public Works Department Engineering staff shall approve these elevations prior to the filing of the final plat.
- e) Plans for drainage improvements within the private drainage reserves and/or common areas must be submitted for review, and payment of inspection fees shall be made prior to construction. Building permits will not be issued until construction is complete.

If a subdivision abuts a stream, the private drainage easements and/or common areas along the stream shall extend to the flow line of the stream at a minimum.

- f) Place the following note on the plat and construction plans: Maintenance of the common areas and/or private drainage easements shall be the responsibility of the property owner's association. No structures, storage of material, grading, fill, or other obstructions, including fences, either temporary or permanent shall be placed within the drainage-related common areas and/or drainage easements shown.
- g) Construction within the limits of this plat will require an erosion control plan in accordance with EPA Storm Water Discharge permitting: CFR Vol. 57, No. 175, September 9, 1992. A copy of the EPA Notice of Intent (NOI) will be required prior to the issuance of work orders or permits for construction activities disturbing an area of ½ acre or greater.
- h) Drainage easements shall be clearly denoted as public or private in the owner's dedication, on the plat, and / or in the plat notes.
- i) Sidewalks shall be installed for all new construction and/or at the time of conversion of a residential use to a more intense use on all lots having frontage on public streets classified as major or minor arterial.
- j) All private roads / streets will have private storm sewer systems.
- k) Engineers / Developers will be contacting PW for a detention determination before they submit their Final Plat and Plans.
- l) Detention Determination
  - A detention requirement determination will not be issued at the Preliminary Plat stage unless the development is located within the current "detention required area".
  - Prior to the preparation of a Final Plat and Construction Plans, the Engineer or Developer may contact the Public Works Engineering Department and receive a Detention Determination for that individual Final Plat
    - This Detention Determination will be specific to the single Final Plat under consideration

- The Detention Determination will be valid for a period of six (6) months
- If the Final Plat and Construction Plans have not been submitted, reviewed, and approved by the Public Works Engineering Department within that 6-month time frame, the Detention Determination will be void and a new Detention Determination must be requested.
- If construction has not started on the development within six (6) months of the approval of the construction plans, the Detention Determination will be void and a new Detention Determination must be requested.

For new commercial developments that do not require hearings before the PC or CC, the Engineer or Developer may contact the Public Works Engineering Department and receive a Detention Determination for that commercial development.

- a) Sanitary Sewer Availability: **SD-2021-00012**
  - b) Existing 10-inch and 15-inch sanitary sewer mains are adjacent to the subject site and a connection will be permitted in accordance with City Standard Specifications.
  - c) All sanitary sewer mains must flow within the existing drainage basin. Proposed sewer mains that will flow to another drainage basin across a ridgeline will not be allowed.
  - d) All sanitary sewer mains must have a minimum cover of 6 feet and a depth no greater than 18 feet.
  - e) The developer will be required to extend a gravity sanitary sewer collection system to each lot or site within the subdivision or land improvement in accordance with City Standard Specifications and the current Subdivision Regulations.

- f) No trees, signs, dumpsters, or fences within 10 feet of any existing or proposed sanitary sewer main.
  - g) All existing unnecessary sanitary sewer services must be abandoned at the sanitary sewer main.
  - h) Public sanitary sewer must be extended to serve the development.
  - i) Side-lot easements adjacent to other lots must combine to equal a total of 20-feet.
  - j) Side lot easements adjacent to other lots must combine to equal a total of 20-feet.
- k) Solid Waste Management

The City can provide residential service provided there is sufficient space for the truck to maneuver to service the addition.

- l) Water Availability: **WA-2021-000010**
- a) The subject site is adjacent to a 12-inch water main in the street right-of-way of NW 150<sup>th</sup> Street, N. County Line Road, and Chambord Drive.
  - b) The developer will be required to extend a minimum twelve-inch water distribution, or larger, as recommended by the approved 2006 Water Master Plan, along the section line street, border, or perimeter of the development and/or all interior water mains for domestic use and fire flow protection.
  - c) The developer will provide an internal (on-site) water distribution system capable of supplying water to each lot or tract within the proposed subdivision or land development in accordance with City Standard Specifications and the current Subdivision Regulations.
  - d) Dead-end water mains must be avoided. Connection to at least two active feeder or grid water mains will be necessary to prevent partial or total shut-off of water supply when a pipeline failure occurs within the proposed development.
  - e) In accordance with ODEQ regulations, the City provides water at a minimum pressure of 25 psi. The owner is responsible for designing and construction of all fixtures to provide adequate domestic and fire protection under minimum pressure conditions. The owner will be responsible for any failure of domestic and fire protection systems which require water pressure in excess of 25 psi.

- f) No trees, signs, dumpsters, or fences within 10 feet of any existing or proposed water main.
- g) All existing and proposed meters must meet current Meter Specifications. Meters must be in a grassed area. All domestic and fire suppression services must have separate water service connections. All existing unnecessary water services must be abandoned at the water main.
- h) Public water main must be extended to serve this property.

## **9. Development Services**

The design of the Montereau Phase 4 final plat is in conformance with the Subdivision Regulations as they relate to developments with between 31 and 100 lots. The overall Montereau subdivision is also in compliance with the subdivision regulations as they relate to subdivision with over 200 lots.

The design of the Montereau Phase 4 final plat varies in layout from the approved preliminary plat. The streets in the plat have been slightly re-routed to remove 2 cul-de-sacs that were originally planned at the north end of the subdivision. This improves the overall traffic flow through the neighborhood and provides better street connectivity. This final plat is in conformance with the approved preliminary plat and with PUD-1095.

The size of this final plat, 15.14 acres, requires approximately 0.48 acres of common area / open space with approximately 0.17 acres (7,670 square feet) of open space for recreational activities. The plat is providing approximately 0.43 acres of common area / open space. A letter from the developer indicates that a pool, bathhouse, and playground have been constructed in the common area of Montereau Phase 2. All residents of the Montereau subdivision may use these amenities. The amenities and the amount of common area previously provided meet the requirements of the Subdivision Regulations.

Section 11250.1 of the Planning and Zoning Code states that all residential developments adjacent to arterial streets must provide a landscaped buffer along the arterial street. It further states that the landscape buffer must be located outside of any subdivision fence and must consist of any combination of trees, shrubs, groundcovers, earthen berms, and/or rock or stone accents, arranged in a manner to achieve visual continuity. The landscape plan provided with this plat has been reviewed and approved. The landscaping must be installed prior to the issuance of a certificate of occupancy for any residence within the applicable final plat.

Separate instruments will be required to be submitted with this final plat for proposed easements lying outside the boundaries of the plat. The instruments will be processed to City Council at the same time as the final plat and will be recorded by the City Clerk. The final plat will not be released until after the easements are recorded.

#### **IV. STAFF RECOMMENDATION**

*Staff recommendations are advisory only and do not constitute Planning Commission decisions. Staff recommendations are based on a technical evaluation of information submitted at the time of review. Planning Commission decisions require a vote of five members to approve or deny an item. 1. Approval of this plat is subject to City Council acceptance of the dedications and improvements or assurance for completion of the improvements.
2. Separate instruments will be required to be submitted with this final plat for proposed easements lying outside the boundaries of the plat. The instruments will be processed to City Council at the same time as the final plat and will be recorded by the City Clerk. The final plat will not be released until after the easements are recorded.

*All Engineering Division and Water/Wastewater Utilities Division requirements must be met. Additional changes to the plat may be required during either Divisions review of construction plans and prior to City Council acceptance.*
