Amendment No. 2 revising the construction contract with United Trenching, Inc., Project SC-1082, emergency 12-inch sanitary sewer repair, 9528 W I-40 Service Road, increase of \$7,826; and accepting the project and placing the maintenance bond into effect.

### **Location:**

# **Purpose:**

To adjust the pay quantities to close out the project.

### **Justification:**

It is necessary to adjust the plan quantities to match the actual quantities for completion of the project.

# **Background:**

Erosion near I-40 and Morgan Road caused a 12-inch sanitary sewer line to wash out. The necessary repairs were beyond the available resources of the Line Maintenance Division; therefore, an emergency was declared. The sewer line was replaced with piers and steel casing for additional protection.

The Ohio Casualty Insurance Company is the surety company for the two-year maintenance bond. Bond No. 87C237124 will remain in effect until the contractor and surety have fulfilled all responsibilities under the maintenance bond.
