## **Purpose:**

To adjust the pay quantities to close out the project.

### Justification:

Several pay items were included with the bid due to unknown site conditions. This amendment removes quantities that were not necessary for completion of the project.

### **Background:**

This project replaced failing electrical switchgear, provided minor renovations to the building's HVAC system, and improved architectural elements so the building can accommodate the new electrical equipment.

Western Surety Company is the surety company for the two-year maintenance bond. Bond No. 30031674 will remain in effect until the contractor and surety have fulfilled all responsibilities under the maintenance bond.
